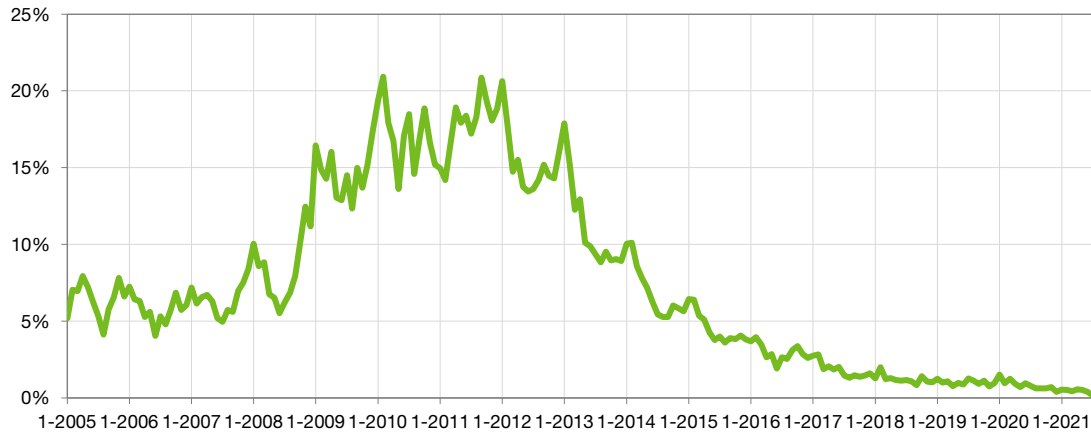

Share of Closed Sales That Were Lender-Mediated: **0.4%**

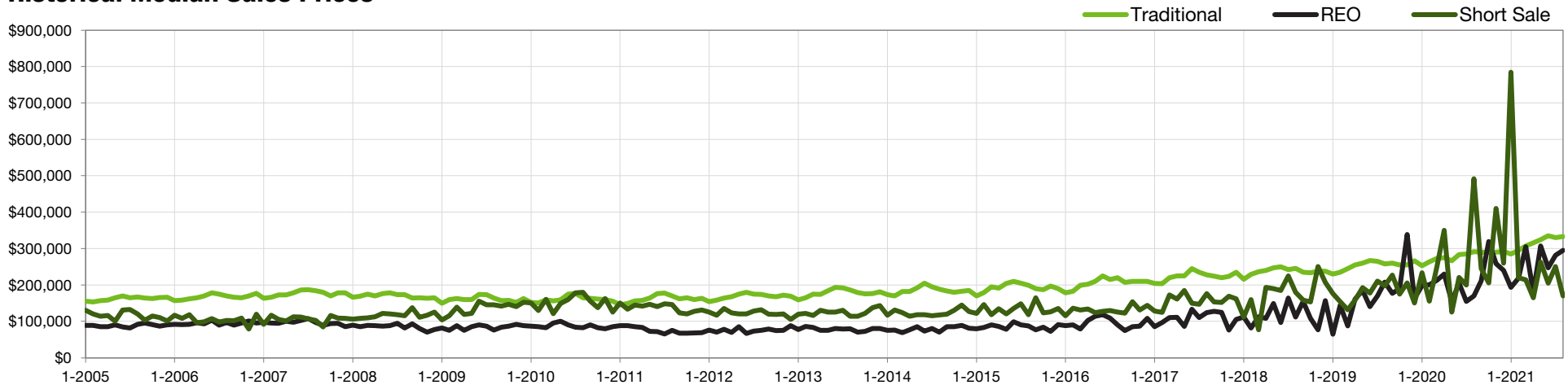
