## New Member Orientation Mandatory Training

The Piedmont Regional Association of REALTORS® New Member Orientation is mandatory for all new members.

In accordance with the Piedmont Regional Association of REALTORS® Bylaws (Article V, Section 2, Qualifications): "As a condition of membership, the applicant agrees to complete a course of instruction covering the Bylaws and Rules and Regulations of the Association, the Bylaws of the State Association, and Constitution and Bylaws of the National Association of REALTORS®."

PRAR New Member Orientation is a four hour training session in both Association business and in the Code of Ethics.

Once member fees and applications is received notification will be given of the next orientation date if you are unable to attend that scheduled orientation, you will be placed in a probationary status and scheduled for the next orientation.

***Failure to attend the second scheduled orientation will result in the new member's application being revoked and all REALTOR® privileges terminated. No monies are refunded. And there will be a reinstatement fee of \$50.00***

As a member of PRAR it is mandatory for all members receive Two and a half hours of Legal Liability/Code of Ethics training every three years. The required training will be established every three years by the Board of Directors. This Mandatory Training will be held 4 to 5 times per year providing several opportunities for you to meet the requirement

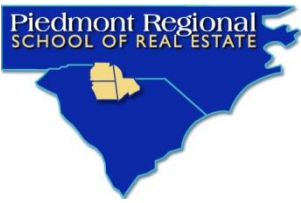

- COMMUNITY SERVICE:** Designs and implements programs, which encourage membership involvement in the community. Promoting the national celebration of home ownership and private property rights.

- Young Professional Network:** YPN helps young real estate professionals excel in their careers by giving them the tools and encouragement to become involved in four core areas:
- RPAC:** Sets goals, plans and implements programs designed to collect funds used in the support of campaigns for candidates running for state and national political office. Plans and conducts educational programs to enlighten membership as to the meaning and importance of RPAC.
- ISSUES/MOBILIZATION:** Responsible for attending local/county/school board meetings, and reporting any issues that might impact our industry. Work with Brokers to mobilize members to action an issue when requested by the Board of Directors.
