QUICK START STEPS

1. Visit the Paso Robles Chamber of Commerce (PRCC) Website

- a. The PRCC website has a number of resources available to help you plan, launch, manage and grow your business
- b. For further inquiries, the PRCC can be contacted at (805) 238-0506

2. Find Location and Check Zoning

- a. Religious organizations are conditionally permitted in zones: AG, RA, R, R1, R2, R3, R3O, R4, R5, OP, CP, C1, C2, C3, RC, M, T3-N, T3-F, T4-N, T4-F, T4-NC, TC-1, TC-2
- b. More information on zoning and access to zoning maps is available online at <u>http://www.</u> prcity.com/government/departments/commdev/planning/zoning.asp
- c. Religious organizations requires a conditional use permit in any approved zone

3. Call Community Development Department

- a. Community Development Department can be contacted at (805) 237-3970
- b. The Community Development Department Planning Division can provide information about zoning compatibility, and reference to other departments that may have input
- c. For information on tenant improvements and development impact fees contact the Building division at (805) 237-3970

- AG: Agriculture RA: Residential Agriculture R2, Residential Duplex/Triplex R3-O: 12 du/ac - office R4: 16 du/ac R5: 20 du/ac OP: Office professional
- CP: Commercial-Neighborhood C1: Commercial-General Retail C2: Commercial-Highway C3: Commercial/Light Industrial RC: Regional Commercial M: Industrial PM: Planned Industrial
- AP: Airport T3-F: Flex T4-F: Flex T4-NC: Neighborhood Center TC-1: Town Centervv TC-2: Town Center

4. Submit Conditional Use Permit Application and Deposit Fee

a. Guidelines to submit are found at <u>http://www.prcity.com/government/departments/commdev/</u> planning/forms-applications/cup-packet.asp

5. Allow 30 Days for the Completeness Review Process

- a. If the application is incomplete or more information is needed, the Community Development Department will send a completeness determination letter requesting you provide additional information
- b. Once the application is completed properly the city will contact the applicant and the project will be scheduled for a Development Review Committee (DRC) meeting and a public hearing before the Planning Commission

6. Meet with the Development Review Committee

- a. After submitting the Conditional Use Permit Application the Community Development department will call and schedule your DRC meeting
- b. The DRC reviews and comments on all major development projects before such projects are scheduled for review by the Planning Commission
- c. The focus of the DRC's review is to determine conformance of proposed projects with the City's: General Plan, Economic Development Strategy, Zoning Ordinance, Design Guidelines, and other applicable City policies, resolutions, and standards



7. Meet with the Planning Commission

- a. After submitting the Planned Development Application the Community Development Department will call and schedule your meeting with the Planning Commission
- b. The Planning Commission is responsible for approving, conditionally approving, or denying a Conditional Use Permit
- c. The Planning Commission has specified land use related decision-making authority
- d. In Paso Robles, the Planning Commission has final decision-making responsibility for actions that are not legislative

8. Apply for Business License Online

- a. Apply online at <u>https://businesslicense.prcity.com/PrimeWeb/Apply/GettingStarted/BusinessLicense</u>
- b. Your business license may remain in a pending status until you are issued a building permit if your selected commercial location requires tenant improvements

9. Set-up a Meeting With the BEST

- a. The Business and Entrepreneurial Success Team (BEST) was created for you!
- b. This resource, offered by the Paso Robles Chamber of Commerce, includes a diversified team of Paso Robles professionals and business owners who are passionate about supporting business and entrepreneurs interested in starting, expanding, or relocating in/to Paso Robles
