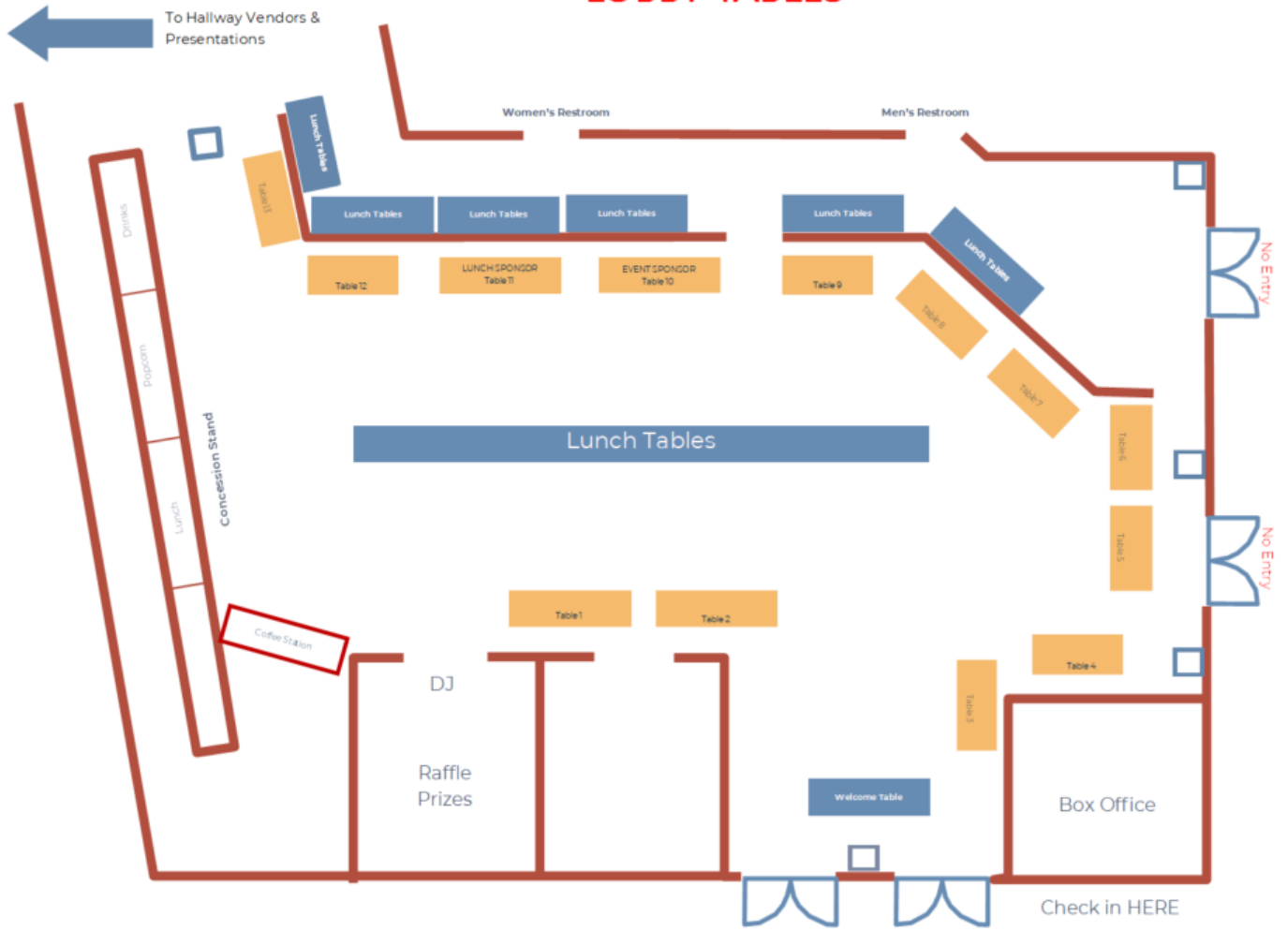

## TERMS & CONDITIONS

- 1. APPLICATION AND ELIGIBILITY.** Application for vendor space, sponsorship, and/or being a presenter at the 2021 Outer Banks Association of REALTORS® (OBAR) REALTOR®Fest must be made on the printed form provided by OBAR, contain information requested and be executed by an individual who has the authority to act for the applicant. OBAR reserves the right to decline any application for any reason, if in OBAR's judgment the products or services to be shown or demonstrated are not applicable to the real estate or technology business or are inconsistent with the stated purpose and mission of OBAR. OBAR further reserves the right in its sole discretion to accept or reject applications based on space limitations and to assign or re-assign booth space as it deems appropriate.
- 2. APPLICATION FEES.** The price for vendor space, sponsorship, and/or presenter space is listed on the applicable application.
- 3. VENDOR STAFF.** OBAR reserves the right, in its absolute discretion to impose reasonable limitations on the number of VENDOR staff within an exhibit and REQUIRES Vendors to obtain OBAR approval for the number of staff prior to the event. *(There will be an extra \$15 charge for each attendee over the set amount to cover food cost.)*
- 4. PAYMENT DATES.** No Vendor space or sponsorship will be assigned or guaranteed until OBAR has received your fully executed application & payment fee in full. Only those companies having made payment in full upon receipt will be listed in the Event Program.
- 5. CANCELLATION.** In the event Vendor/Sponsor notifies OBAR of intent to retract his/her contract on or before August 1, 2021, Vendor/Sponsor shall be entitled to retain fifty percent (50%) of the full vendor/sponsorship fee as liquidated damages and not as a penalty. If OBAR receives such notice of the Vendor's/Sponsor's repudiation after August 1, 2021 OBAR reserves the right to retain the full vendor space or sponsorship fee as liquidated damages and not as a penalty, and to resell or reassign the booth space.
- 6. DOOR PRIZES.** ALL door prizes shall be awarded by vendor **during vendor time OR the day after the event.** Due to time constraints, we are unable to award vendor prizes during lunch or after the final presentation.
