Our COVID-Conscious Plan for Resuming Activities

The Chamber is currently in Phase 2 of our COVID-Conscious Plan

Phase 2

- Chamber staff will return to office working on a rotating basis. Members/guests are requested to call in advance of in-person visits and to wear a mask when visiting the office.
- Non-essential businesses may open or increase capacity.
- Gatherings of up to 25 persons may take place.
- In-person Chamber activities or meetings may resume at discretion of Committee Chairs—Gatherings will be capped at 20 persons.
- No large in-person events (After-Hours, GMM, WIB luncheons).

Phase 3

- Chamber Office will re-open fully to the public. Members/guests are requested to wear a mask when visiting the office.
- Most businesses may re-open.
- Maximum gathering size to be determined by the Mayor's Office.
- In-person Chamber activities or meetings such as After-Hours, GMM, WIB luncheons will resume—Gatherings will be capped at 5 fewer persons than the maximum allowed gathering size.
- No large special events (Taste of Donelson Hermitage, Gerry Neenan Memorial Golf Tournament, Christmas Parade) will take place.
