TEXAS DISPOSAL SYSTEMS

Governor Abbott has outlined official steps to reopen Texas and announced that his previous stay-at-homme order would be lifted on April 30th. The reopening of the state's economy will unfold in phases.

- <u>Phase 1</u>: Beginning May 1st, a wide range of businesses will be allowed to open at 25% capacity.
- <u>Phase 2</u>: Beginning as early as May 18th, after evaluating data and results, businesses may be allowed to increase to 50% capacity.

Though the Governor's order allows a return to business, it does not require businesses or business owners to do so.

Businesses and activities that can open under the new Executive Order include:

- All dine-in restaurants that have less than 51% of their gross receipts from the sale of alcoholic beverages and are not required to post the 51% sign required by Texas law as determined by the Texas Alcoholic Beverage Commission.
- All retail stores, malls, movie theaters, museums and libraries.
- Sole proprietor businesses.
- All licensed healthcare professionals can return to work with few restrictions.
- Churches and places of worship can expand their current allowable capacity, with continued distancing measures advised.
- Outdoor sports of no more than four participants in proximate interaction will be allowed.
