


SB 2656 & HB 4430

Small Business Property Tax Relief Act

Inflation, high-interest rates, and a workforce shortage have taken their toll on many small businesses. Property taxes are also hurting Illinois businesses. Policymakers can support the small business community by passing legislation that provides property tax relief to the small businesses that drive our economy.

THE LEGISLATION

The Small Business Property Tax Relief Act will provide a \$1500.00 tax credit to small businesses to offset the rising costs of property taxes.

Eligible small businesses must:

- Be registered and operate within the state of Illinois.
- Have 50 or fewer employees.
- Own or lease property in Illinois that is subject to property taxes. Home offices do not qualify for this tax credit.
- Comply with all state tax obligations, which encompass income, sales, and employment taxes.

TAX CREDIT FOR SMALL BUSINESSES

Small businesses can receive a tax credit up to 10% of their annual property tax payments, capped at \$1500.00. Tax credits are awarded based on the date the appropriate paperwork is submitted. A total of \$50,000,000.00 has been allocated for this program, which will span over five years. Stakeholders will prioritize disseminating information about this tax credit program in disinvested communities.

WHY THIS LEGISLATION IS IMPORTANT

Small businesses drive our economy, create jobs, and support local communities. With incentive programs and tax credits so often focused on large corporations, this tax credit will help small businesses navigate these challenging economic times and position them for future success.

SB 2791 & HB 4571 ECONOMIC INCENTIVES FOR SMALL BUSINESSES

Small businesses drive our economy and support local communities. Accordingly, Illinois policymakers should allocate a fair share of economic incentives to the small business community. Applying for these incentives should not require small businesses to spend an unreasonable amount of time or resources. So long as Illinois uses economic incentives to foster the growth of our economy, small businesses should receive a fair share of these opportunities. The SBAC is advocating for legislation that will ensure this happens.

50% OF ALL ECONOMIC INCENTIVES

Access to Incentives

This legislation mandates that businesses with 50 or fewer employees receive 50% of the economic incentives awarded by the state.



Transparency

The legislation requires the agencies that award economic incentives to disclose whether they have allocated a fair share of economic incentives to small businesses.

COLLABORATE WITH POLICYMAKERS

Collaboration

The SBAC will collaborate with policymakers to formulate and implement programs focused on providing incentives to businesses with 50 or fewer employees.

Large and small businesses play a pivotal role in the Illinois economy. Passing this bill will ensure that along with providing resources to larger companies, small businesses also have access to economic incentives. Supporting small and local businesses will improve the business climate in Illinois, create jobs and strengthen our economy.

SB 3108 & HB 4472 MAKE HEALTH INSURANCE MORE AFFORDABLE BY CONTROLLING THE COST OF PRESCRIPTION DRUGS

Small businesses struggle to afford quality health insurance. Indeed, the high cost of health insurance drains the cash reserves of small businesses and makes it difficult for them to recruit and retain employees. Excessive drug prices deeply impact the cost of premiums for small businesses. The rising cost of health insurance is unsustainable, and establishing a Prescription Drug Affordability Board is one way to tackle this issue and reduce premiums for small employers.

Attacking the High Cost of Certain Drugs

SET UPPER PAYMENT LIMITS This legislation will establish a Prescription Drug Affordability Board, an independent body with the authority to evaluate excessively highcost drugs and set Upper payment Limits (UPLs) that apply to the entire supply chain.



Targeted Approach

The Prescription Drug Affordability Board will focus only on unreasonably priced drugs that drive up the costs of health insurance.



Collaboration and Expertise

The legislation creates a stakeholder council that includes people with experience in pharmaceutical business models, expertise in supply chains, as well as professionals with clinical training. This board will provide the public with a voice on drug prices and the opportunity to be heard on issues addressed by Prescription Drug Affordability Boards.

AFFORDABLE COVERAGE FOR SMALL BUSINESSES

More Affordable Coverage

The Prescription Drug Affordability Board can reduce the cost of quality health insurance coverage for small businesses.

HB 3418

THE SAFER COMMUNITIES & SMALL BUSINESS ACT

Illinois businesses are struggling to hire employees to support their operations. Formerly incarcerated citizens often struggle to find employment, contributing to high recidivism rates.

Providing wage subsidies for businesses that hire formerly incarcerated individuals, and an increased tax credit for small businesses that hire returning citizens, will support small businesses struggling to hire employees, foster opportunities for formerly incarcerated individuals, improve public safety, and reduce the costs of incarceration. House Bill 3418 provides the framework for this impactful program.

RELIEF FOR SMALL BUSINESSES

SMALL BUSINESS RELIEF

HB 3418 provides wage subsidies and a meaningful tax credit to small businesses that hire formerly incarcerated individuals. Businesses of all sizes are eligible for wage subsidies to maximize the number of returning citizens entering the workforce.



PUBLIC SAFETY

When individuals returning from incarceration become stably employed, their risk of recidivism drops by 62%. This legislation will reduce crime and improve public safety.

IMPROVE ILLINOIS ECONOMY

ILLINOIS ECONOMY

HB3418 will reduce reincarceration costs and increase revenue for the state through the income and sales taxes paid by returning citizens. This will foster long-term economic growth for the state.

HB 3418 passed the House and remains in the Senate. Let's build bridges between businesses and formerly incarcerated people by passing this legislation in 2024!

HB 4485

SMALL BUSINESS JOB CREATION TAX CREDIT

The Small Business Job Creation Tax Credit, established in 2010 in response to the 2008 recession, aimed to encourage small business owners to generate employment opportunities. Applicable to businesses with fewer than 50 employees and those participating in Governor Quinn's "Put Illinois to Work" program, the credit provided \$2,500 per new job. However, the credit lapsed in July 2016 and has not been renewed.

Requirements to qualify for the tax credit:

- Business has no more than 50 full-time employees
- Increase net employees and maintain that increase over a 12-month period, starting from the date of hire
- The new job created must pay a basic wage for at least 35 hours per week

Small businesses drive the Illinois economy, and sustaining their growth is crucial. Programs supporting these employers can ensure robust job growth. The Small Business Job Creation Tax Credit Act, at \$2,500 per net gain employee, proves more financially beneficial for Illinois and taxpayers than many other credits. For instance, a small firm hiring at \$40,000 generates an estimated \$1,800 in income taxes in the first year alone, reducing the state's initial loss to just \$700. With the average tenure of an employee being 4.1 years, the state stands to collect \$7,712 in income tax over the long term modest \$2,500 investment. This from a projection excludes potential increases in other taxes due to disposable income.
