#### Residential Construction, Sept. 2019



The U.S. Census Bureau and the U. S. Department of Housing and Urban Development jointly announced the following new residential construction activity for September 2019:

#### **Building Permits Down 2.7%**

Privately-owned housing units authorized by building permits in August were at a seasonally adjusted annual rate of 1.387.000. This is 2.7% below the revised August rate of 1,425,000 but is 7.7% above the September 2018 rate of 1,288,000. Singleauthor-izations family September were at a rate of 882,000; this is 0.8% above the revised August figure of 875,000. Authorizations of units buildings with five units or more were at a rate of 470,000 in September.





#### **Housing Starts**

Privately-owned housing starts September were at a seasonally adjusted annual rate of 1,256,000. This is 9.4% below the revised August estimate of 1,386,000, but is 1.6% above the September 2018 rate of 1,236,000. Single-family starts housing September were at a rate of 918,000; this is 0.3% above the revised August figure of 915,000. The September rate for units in buildings with five units or more was 327,000.

#### **Housing Completions**

in Privately-owned housing completions in September were at a seasonally adjusted annual rate of 1,139,000. This is 9.7% of below the revised August estimate of 1,262,000 and is 1% below the 00. September 2018 rate of 1,150,000. in Single-family housing completions in September were at a rate of 852,000; this is 8.6% below the revised August rate of 932,000. The September total for units in buildings with five units or more was 285,000.

#### Pending Home Sales Grew 1.6% in August

Pending home sales increased in August, a welcome rebound after a prior month of declines, according to the National Association of Realtors®. Each of the four major regions reported both month-overmonth growth and year-over-year gains in contract activity.

The Pending Home Sales Index climbed 1.6% to 107.3 in August, reversing the prior month's decrease. Year-over-year contract signings jumped 2.5%. An index of 100 is equal to the average level of contract activity.

"It is very encouraging that buyers are responding to exceptionally low interest rates," said Lawrence Yun, NAR chief economist. "The notable sales slump in the West region over recent years appears to be over. Rising demand will reaccelerate home price appreciation in the absence of more supply."

All regional indices are up from July, with the highest gain in the West region. The PHSI in the Northeast rose 1.4% to 94.3 in August and is now 0.7% higher than a year ago.

#### Pallet Consultants to Invest \$3.1 Million in Dunn, North Carolina **Facility**



Carolina, a manufacturer and distributor Governor Cooper. of pallets, will create 50 new jobs in Harnett County, Governor Roy Cooper announced recently. The company will invest \$3.1 million to establish a new plant in Dunn.

"With more than 470,000 workers, North Carolina has the largest manufacturing workforce in the Southeast. We know Pallet Consultants can expand with great confidence in our state's workforce,

industries include manufacturing, agriculture, food and beverage, pharmaceuticals, transportation, retail, automotive and others.

"My team and I are excited for the opportunities made available by further expanding into the great state of North Carolina and are thankful for its support." said Pallet Consultants CEO Gus Gutierrez. "We've been servicing clients in the state for some time now, and with this new added facility we will be able to serve the bustling North Carolina economy with even greater speed and efficiency. PC is excited to create new jobs with competitive wages and comprehensive benefits, raising the standard of living for 50 people and their families while growing the Pallet Consultants family."

"Pallet Consultants' decision affirms the strength of North Carolina's manufacturing economy, which is the fifth highest in the nation," said North Carolina Commerce Secretary Anthony M. Copeland. "Our business climate and their new East Coast location in Harnett County is a winning formula for a manufacturer and distribution center."

The North Carolina Department of Commerce led the state's support for the company's decision.

Although salaries will vary depending on the position, the average wage for all new positions will be \$38,080. The current average annual wage in Harnett County is \$33,061.

A performance-based grant of \$100,000

from the One North Carolina Fund will help facilitate Pallet Consultants expansion in Harnett County. The One NC Fund provides financial assistance to local governments to help attract economic investment and to create jobs. Companies receive no money upfront and must meet job creation and capital investment targets to qualify for payment. All One NC grants require a matching grant from local governments and any award is contingent upon that condition being met.

"Pallet Consultants will find great success in Harnett County," said N.C. Senator Jim Burgin. "We welcome them and the new jobs that will be created from their investment in our state."

"Manufacturing is important to our community," said N.C. Representative David R. Lewis. "We are proud of the pipeline of talent and the quality of life we're able to afford growing companies like Pallet Consultants."

In addition to N.C. Commerce and the Economic Development Partnership of North Carolina, other key partners in the projectinclude the North Carolina General Assembly, North Carolina Community College System, Harnett County Board of Commissioners, Harnett County Economic Development Office and the City of Dunn.

# CHEP, Kimberly-Clark and SmartWay Logistics find the formula to reduce empty running and CO2 emissions



Kimberly-Clark's logistics supplier will share trucks with the pallet pooling company CHEP on the Czech Republic – UK route, reducing empty running by at least 10 percent. SmartWay Logistics, the 4PL brand of Van der Wal, will act as a trustee and operations partner.

Starting from September 2019, trucks transporting Kimberly-Clark's hygiene and personal care products from the Czech Republic to the UK will be reloaded with CHEP's reusable pallets on the way back from the UK to the Czech Republic. On average, both companies will share three trucks on a daily basis. SmartWay Logistics will coordinate the two transport flows in such a way that empty running

Starting from September 2019, trucks and standstill are prevented, which transporting Kimberly-Clark's hygiene increases the productivity for the carriers.

The three-party collaboration will mean a reduction of 70,000 kg of CO2 emissions per year, a significant reduction in empty running and ultimately important savings in freight costs for both Kimberly-Clark *Cont'd on Page 22* 

and CHEP. "Our joint goal is to reduce

CHEP. "Our joint goal is to reduce empty running by at least 10 percent," explained Henk Van der Wal, CEO of Van der Wal. "Our calculations show that we will certainly achieve that goal. From an average empty running of 20 percent, we go back to 5 to 10 percent."

According to Michael Gierloff, European Transport Director of CHEP, the logistics collaboration fits perfectly with CHEP's European Collaborative **Transport** Solutions program. "Our Collaborative Transport Solutions program counts over 210 partners focusing on decreasing the existing inefficiency in European transport through the reduction of empty running and improved utilization of transport," he said. "The implemented projects have reduced over 4700 tons of CO2 emissions during the last 12 months delivered important economic benefits to all partners."

Mark Lowe, European Transport Manager at Kimberly-Clark, is also enthusiastic about the logistics collaboration. "Kimberly-Clark has been working to

reduce our greenhouse gas emissions and climate impact from our supply chain," he added. "Sustainable transportation solutions such as this project serve to reduce empty miles and emissions, and at the same time, help us to achieve our global sustainability goals for energy and climate."

Earlier in October, CHEP announced the European launch of its "Zero Waste World" initiative at two major European events: the IGD Supply Chain Summit in London and the Sustainable Brands Madrid meeting. The Zero Waste World initiative was introduced in North America earlier in the year. It is a close collaboration that brings together leading retailers and manufacturers to develop smarter and more sustainable supply chains. Among other things, CHEP is working to build a waste-free supply chain collaborative solutions for the industry.

# How to best prepare your company against wrongful termination and hiring discrimination lawsuits

Employment practices coverage might be right for your company

In the last two decades, the frequency of employment practices lawsuits has risen an astounding 400%, according to WPA-associate member HUB International. Employees must be vigilant when it comes to protecting themselves against claims of discrimination and having Employment Practices Liability Insurance (EPLI) is a good first step.

"It has been my experience that many companies in the wood pallet industry don't carry employment practice liability coverage," Brian King, Vice President, HUB Healthcare told Western Pallet Magazine.

As a result, he said, employers reluctantly hang onto problematic employees on because they fear being sued for wrongful ret termination. This reluctance often leads exato bad workplace culture and lower production due to a perceived lack of Emleadership on the owner's part. "I see and son hear a lot of fear about wrongful what termination suits."

"It is important to note," King continued, "an employer doesn't have to do anything "wrong" to be sued for wrongful termination. They just have to be accused of wrongdoing. When letting an employee go, we have seen claims based



on alleged discrimination, alleged retaliation, or status as an "alien", for example."

Employers can also be sued for not hiring someone. Discrimination suits can arise when an employer doesn't hire someone over the age of 40 or of gender or race that they allegedly won't hire. "A good employment practices liability policy will afford some protection against this sort of allegation," he said.


Most insurance companies will also provide a Human Resources service to their clients as part of their EPLI coverage.

their clients as part of their EPLI coverage. While various insurance carriers may offer different services, almost all have advice lines to help you set up proper documentation around employee issues and employee discipline leading up to termination. "This is of great benefit to the employer should they, in fact, be sued," King said. "They would have proper documentation regarding what led to the termination, the steps that were taken to develop the employee prior to their being terminated, and what the outcome of that training was."

All employment liability policies are written differently, King noted. Each has exclusions and coverages and it is important to work with an experienced broker to make sure a comprehensive policy is being purchased.







## Timcon AGM Focuses on Brexit and Collaboration

The Timber Packaging & Pallet Confederation (Timcon) held its annual general meeting in Cardiff, Wales on September 10. Subjects covered in presentations included Brexit, PRNs (packaging recovery notes), packaging waste and cross-industry collaboration.

Speaking on Brexit, Timcon president John Dye said the organization had worked intensely with government, Defra (UK Department of Food, & Rural Affairs) and the Forestry Commission, among others, to ensure the sector and its supply chain customers were as prepared as possible.

He added that there is still a "severe lack of accurate guidance from government" on how to prepare for Brexit, saying this is a problem faced by every country in the EU, not just UK manufacturers.

However, he said, Timcon has developed a strong dialogue with Defra, which is helping promote to decision makers the fact that the risk posed by wood packaging material (WPM) to plant health remains low, regardless of whether the UK is in the EU or not.

Fiona McKenna of Northern Ireland's Department of Agriculture, Environment and Rural Affairs (DAERA) told the meeting that although its advice is that all WPM entering the EU from the UK after Brexit should be ISPM15 compliant, its plant health policy is not changing on EU exit and DAERA was engaging with business on an industry-wide basis.

"Our department will work collaboratively to protect trade and enhance biosecurity on the island of Ireland," she said, adding that while the necessary control systems are already in place, the workload after Brexit in terms of issuing phytosanitary certificates would increase significantly, so DAERA's focus is on increasing its capacity to ensure it can deal with this.

Delegates also heard that Timcon has played an important role in the government's consultation process on reforming the UK packaging producer responsibility system, notably the review of the percentage recover targets.

Thanks partly to Timcon's involvement, Defra has proposed that the current 48% target should reduce to 36%, before dropping to 30% in 2025 and 2030. The UK will then be in line with Europe.

Timcon has also lobbied hard on the subject of PRNs, said Mr Dye and had been part of the Advisory Committee on Packaging (ACP). This involved meetings with the Wood Recyclers Association, the Wood Panel Industries' Federation (WPIF) and Confor, with the goal of presenting a "united wood" position.

"Collaborations such as these are a vital part of Timcon's work in representing its members, both at home and on the international stage," said Mr Dye.

#### **Madison Immigration Raid Sparks Familiar Concerns**

An ICE raid took place this October at a Madison, Nebraska business called D & D Industries, a manufacturer of skids and pallets located across the road from a sprawling Tyson meatpacking plant. Madison is a town about a dozen miles south of Norfolk with about 2400 people, roughly half of them Hispanic, according to the Census Bureau.

Nicole Alberico, a spokesperson for Immigration and Customs Enforcement, said special agents with ICE's Homeland Security Investigations conducted the law enforcement operation Wednesday and arrested 14 people on immigration violations – 11 from Mexico and 3 from Guatemala, Read more.

#### Uber's new freight division starts carbon-cutting trial with IPP

The brand-new freight division of digital platform Uber has turned to one of Europe's leading wood pallet rental providers to help it cut empty running on its newly-established routes. After expanding to Europe in March, Uber Freight has teamed up with IPP on a trial basis which, if successful, could be rolled out across IPP's other European businesses, including the UK.

After researching 3PL suppliers to partner with, Uber Freight opted for a trial with IPP to service their carrier requirements in the Netherlands after building up a network of shippers.
