CHRISTMAS PARADE "HELPFUL HINTS"

The Elkhorn Christmas Parade is held on Saturday, December 3, 2022 at 1:30 p.m.

Parade staging takes place at the Walworth County Fairgrounds where the route begins and ends. To participate, complete the application form and liability form(s) and return to the Elkhorn Chamber by Friday, November 25, 2022.

Parade Guidelines, Rules & Information

- 1. The Elkhorn Chamber has devoted a portion of its website, www.elkhornchamber.com, to Christmas Parade information. The section includes entry forms, information and helpful parade hints. Parade lineup begins at 10:30am at the fairgrounds and entries must arrive and be in position no later than 1:15pm. Also, line-up information will be emailed as well as available on the website the week of the Parade.
- 2. For the safety of the children, candy or other items **may not** be thrown from any vehicle, but should be **handed out** by people walking in the parade.
- 3. All vehicles must maintain a safe speed. Fast acceleration of vehicles is not allowed. Please maintain a space of <u>3 car lengths</u> between your entry and the entry ahead of you.
- 4. Dogs must be on leashes and up to date on vaccinations.
- 5. All animal waste must be cleaned up on the parade grounds and throughout the route.
- 6. All parade entries must have a signed 2022 Christmas Parade liability waiver form on file with the Elkhorn Area Chamber of Commerce & Tourism Center in order to participate in the parade.
- 7. We once again remind you: please NO SANTAS as part of your entry.
