National Grant Opportunity - Verizon Small Business Relief Fund (LISC)

Thanks to a \$2.5 million investment from Verizon, LISC is offering grants to help small businesses nationwide fill urgent financial gaps until they can resume normal operations or until other more permanent financing becomes available. The grants can be used for paying rent and utilities, meeting payroll, paying outstanding debt to vendors, and other immediate operational costs.

Update from the Dept. of Labor on Work Hours for School-age Children

The Dept. of Labor and Industry in Minnesota has clarified that <u>normal child labor laws</u> around hours that school-age children can work are in place. Now that distance learning is in effect for students, businesses should follow the laws as if school were in session. This limits the number of hours and the time of day that students can work who are 17 and younger.

Small Business Owner's Guide to the CARES Act

The US Senate Committee on Small Business & Entrepreneurship has created an 11-page document that provides answers to frequently asked questions on several topics related to small businesses during the COVID-19 pandemic: Paycheck Protection Program Loans, Small Business Debt Relief Program, SBA Economic Injury Disaster Loans and \$10,000 grants, Small Business Counseling and Contracting, and Small Business Tax Provisions. <u>Click here</u> to read the guide.

Advocating for Property Tax Extension for Businesses

We know that cash flow is a challenge right now for many of our businesses in the Hibbing Area Community, and the upcoming May 15th property tax payment may be a burden on your business as you work to improve cash flow and access financing to help your business through this time. The Hibbing Area Chamber has partnered with the Minnesota Chamber of Commerce and many other chambers and organizations through the state to encourage Governor Walz and the Commissioner of Revenue to issue a state-wide 60-day extension of business property tax payments. Businesses in virtually every industry, all sizes and throughout Minnesota have been negatively impacted.

We recommend action be taken by the Governor and Commissioner of Revenue so there is uniformity across the state versus a county-by-county approach. This is just one way that we are working to advocate for our business community and provide value to our members during this time. We believe that we can find solutions that help businesses in this critical time while maintaining cash flow and funding for essential county services funded by property taxes. We will continue to work with our government officials and legislators at all levels to advocate for your business during this crisis and every day.
