

Legislative Affairs Update



Legislative Affairs Strategic Plan

The NAIOP SoCal Legislative Affairs Committee, Chaired by Stephane Wandel, has adopted a five-year Strategic Plan. The plan includes enhancing NAIOP SoCal's visibility among policymakers, elected officials, regulatory agencies and strategic business organizations. A key priority includes educating elected officials on the benefits the members of NAIOP SoCal bring to their communities by providing jobs and economic growth. The NAIOP SoCal Board of Directors affirmed its support of the Strategic Plan to ensure NAIOP SoCal continues to have strong voice at the public policy table.

Costa Mesa Lifts Commercial Eviction Moratorium

On Tuesday, April 6th, the Costa Mesa City Council unanimously passed an Urgency Ordinance that will take effect immediately to repeal the temporary



moratorium on the eviction of commercial tenants who were unable to pay rent due to the impacts of COVID-19.



Indirect Source Rule Task Force

NAIOP SoCal is leading the opposition to a proposed rule by the South Coast Air Quality Management District (SCAQMD) that would heavily regulate and tax warehouses in Southern California. The proposed rule is called the Indirect Source Rule (ISR). NAIOP SoCal Exec. Committee Member Fran Inman Chairs the ISR Task Force.

In early March, NAIOP SoCal launched a new digital advocacy platform to make it easier for members and allied organizations to seamlessly communicate with elected officials via email, video messages and through social. Since the launch of the platform, nearly 2000 emails by over 160 companies have been sent to the SCAQMD Board of Directors in opposition to the ISR Rule. The SCAQMD Board is scheduled to vote on May 7 on whether to adopt the ISR.
