Message from NAIOP SoCal CEO

I often get asked, "How many programs and events does NAIOP SoCal" organize each month. The answer is a lot!

Let's take October which began with our <u>Community Garden Clean-</u> up in Santa Springs sponsored by Birtcher Development. Next was our premier event, the 30th Anniversary of <u>Night at the Fights</u>. This iconic event was commercial real estate's marquee networking bonanza that included two of our very own, <u>Steve Madigan</u> and <u>Charles Banks</u>,

I am pleased to provide the NAIOP SoCal 2022 Voter Guide.

This Voter Guide is meant to serve as a resource to you as you complete your ballot. There are many local and state policies under consideration that impact the commercial real estate industry and the jobs, economic growth and quality of life we provide to communities. In determining our ballot recommendations, we considered voting records and other actions relating to land use, taxes, regulations, building code requirements and

development restrictions. NAIOP SoCal is nonpartisan and does not support or oppose candidates or ballot measure based on any political or party affiliation.

With 122 cities, two major counties and special districts such as the South Coast Air Quality Management District (SCAQMD) and California Air Resources Board (CARB) this Voter Guide does not cover every election. The final recommendations were developed based on input from the Legislative Affairs Committee, members at large and the two Political Action Committees.
