Mr. Folino is a "Washingtonian" born on January 23, 1945. Reared in Seattle, Washington, he attended Central Washington State University where he majored in social sciences and graduated cum laude with a Bachelor of Arts degree. After graduation, he immediately enrolled at Seattle University where he received his Master of Business Administration degree with a concentration in organizational behavior.

In 1970, Mr. Folino joined the Xerox Corporation where he held various positions including National Accounts Manager, Branch Sales Manager, Regional Sales Planning Manager, District Sales Manager and finally, Region General Manager. Mr. Folino was part of the original Xerox team that launched the first Ethernet networking products into the marketplace.

In 1984, Mr. Folino joined Eczel Corporation as Vice President and General Manager and was later promoted to President and Chief Operating Officer by 1986. Eczel was a subsidiary of Crown Zellerbach, a Fortune 500 company, and a national distributor of microcomputers, supplies, accessories, and peripherals.

Mr. Folino joined the Thomas-Conrad Corporation in 1990 as Managing Director of their international business. After a very short time, Paul was promoted to President and Chief Operating Officer of the company which experienced very high growth in the high-speed network interface sector and was recognized by "INC. Magazine" as one of the top fastest growing privately held corporations in America.

Mr. Folino joined the Emulex Corporation in May 1993 and served as President and Chief Executive Officer as well as Chairman and later Executive Chairman before retiring as a director in May 2015 upon the sale of Emulex to Avago Technologies Limited for over \$600 million. Mr. Folino was recognized as the 1999 Orange County Co-Entrepreneur of the Year for technology as well as Ernst & Young's 2000 Orange County Director of the Year for high growth technology. In 2006, he was recognized by the Los Angeles Times as "one of the top 100 most influential" people in Southern California and "Orange County Philanthropist of the Year" by the Association of Fund Raising Professionals. More recently, in 2013 through 2020 Mr. Folino was recognized by the Orange County Business Journal as one of the "top 500 most influential business leaders" in Orange County; in 2015 elected into the Toshiba Classic "Hall of Fame"; in 2015 elected into the Cal State Fullerton's Athletic Hall of Fame; and elected to the West Seattle High School Hall of Fame in 2018.

Additionally, Mr. Folino has served on several non-profit boards including Chapman University; Cal State Fullerton University; the Discovery Science Center; the Orange County High School of the Arts; the Orange County Performing Arts Center; and South Coast Repertory Theatre. In the corporate sector, he currently serves on the boards of Commercial Bank of California as Lead Director and Lantronix, Inc. as Chairman of the Board. Mr. Folino has also previously served on the boards of Microsemi Corporation until its sale to Microchip in 2018 for \$9.9B and CoreLogic, Inc. as its Chairman of the Board until its sale in 2021 to a private equity company for \$8B.
