This award will be presented to the company who demonstrates their efforts and results from investing in their staff development to support the business and its growth.

Criteria

- 1. The entrant should describe their business in 400 words or less enabling judges to gain an understanding of their company, its history, customers, competitors, challenges, opportunities and anything else that the entrant feels is relevant (unscored).
- 2. The entrant should demonstrate how they have developed a robust training and development strategy aligned to its business plan with clear and defined objectives.
- 3. The entrant should evidence how all staff are able to access development opportunities, including through apprenticeships, and progress through the organisation.
- 4. The entrant should demonstrate how the organisation's leaders and managers take responsibility for their own development and progression and how this contributes to the strategic development of the organisation.
- 5. The entrant should demonstrate how their firm's commitment to training and development has positively impacted on their customers.
- 6. The entrant should demonstrate how training and development has contributed to their business's success and growth, including the business's financial performance.

Please note:

- All questions are given equal weighting.
- All completed entry forms and evidence must be returned to events@doncaster-chamber.co.uk.
- Entrants may provide a maximum of 3 pieces of evidence to support their submission. Evidence must consist of images only i.e. charts/pictures. Entrants may be asked for additional information, including evidence of financial information, at the interview stage (Stage 2).
