The Rockwall Area Chamber of Commerce is a diverse organization with approximately 720 members. Each year a nominating committee is appointed by the Chairman of the Board to select candidates to serve on the Board of Directors for a three-year term.

Chamber partners who have an interest in being considered for the Board of Directors are encouraged to do so by submitting a candidate resume form. Please return to the Chamber of Commerce President or Nomination Committee Chair, Eva Hummel, no later than 5:00 pm on Thursday, October 19, 2021.

While the nominating committee will not be limited to selecting only from those who volunteer, it will be its responsibility to consider all candidates objectively and select those, who in its judgment, best meet the requirements established for service on the Board of Directors.

#### The candidate must:

- Be a member in good standing of the Chamber
- Participate in the Investment Tiers Dues and Sponsorship Program structure at the Business Level or greater.
- Attend and participate in an Annual Strategic Planning session.
- Attend regularly scheduled monthly board meetings as well as any special meetings called by the Board Chair.
- Commitment for the term to support Chamber programs and events with their presence.
- Agree to attend an annual planning session, monthly board meetings and special meetings called by the Chairman of the Board
- Capable and willingness to Chair and/or serve in a leadership role in one of the Chamber committees.

Other desirable qualities candidates should possess include:

- A record of service/leadership in the community and/or within the Chamber
- A leader in his or her business or profession
- Background that provides sound judgment in considering problems and policies
- Support Chamber financially by attending events and participating in Strategic Alliance Investments
- Capable and willing to accept a leadership position on the Board of Directors

#### **Board of Directors Responsibilities**

Potential Directors of the Rockwall Area Chamber of Commerce should be prepared to accept the following responsibilities:

The Board of Directors is the elected policy making body of the Rockwall Area Chamber of Commerce who is responsible for supporting and advocating for the mission and strategic plans of the Chamber. Its members represent the business and professional leadership of the community. A Board of Director holds responsibility for the vision, policies and solvency of the Chamber. The Board is responsible for approving the annual Program of Work and supporting budget, receiving and acting on committee reports and recommendations and approves the structural organization of the Chamber. The Board maintains close contact with the community's business leaders and is accountable to the membership and to the bylaws which control the functions of the Chamber. They are to enhance the Chamber's public standing and advocate for its issues in the community and at all levels of government and participate in the nominating process and assist with the recruiting, and mentoring of new Board members.
