Mission and History

MISSION: The mission of the Vail Board of Realtors® - TO SUPPORT OUR MEMBERS AND SERVE THE COMMUNITY THROUGH EDUCATION, TECHNOLOGY, PHILANTHROPY, AND ADVOCACY.

HISTORY: The Vail Board of REALTORS® was formed by a local group of real estate professionals in the early days of Vail. The Vail Board of REALTORS® received its charter from the National Association of REALTORS® in 1978, just a few years after Vail opened in 1962 and a few years before Beaver Creek Resort opened in 1982. This group of real estate and Vail Valley pioneers saw the benefits of joining with the National and State associations to ensure ethical and professionalism in the profession and to protect homeownership rights.

The Vail Board of REALTORS® is centrally located in the Riverwalk complex in Edwards, Colorado. The current space has been home to the Vail Board of REALTORS® since 2006. The office space offers a Board Room and Multi-Purpose Training Room. The Vail Board of REALTORS® shares the office space with Vail Multi-List Service, a wholly-owned subsidiary of the Vail Board of REALTORS®.

Vail Multi-List Service

MISSION: The Mission of the Vail Multi-List Service - TO PROVIDE RELEVANT TECHNOLOGY AND ACCURATE DATA TO OUR MEMBERS.

The Vail Multi-List Service (VMLS) offers REALTORS® access to the MLS for the entire Vail Valley. The VMLS provides REALTORS® real property information for most of Eagle County. The jurisdiction includes all the towns along the I-70 corridor from East Vail to Dotsero and into Northern Eagle County.

Participation in the VMLS is available to Vail Board of REALTORS® members and members of other REALTOR® boards in the state of Colorado, who actively endeavor to list and sell real property within the Vail MLS service area. (The VMLS service area is Eagle County, excluding the towns of Basalt and El Jebel). As a requirement for Participation, the REALTOR® member wanting to participate in the Vail MLS, can only apply if their Employing Broker applies to become a Participant of the Vail MLS. A new office application may be required as well. The Vail MLS waiver must be filled out and signed by the Employing Broker if the remainder of the REALTORS®s in that office do not wish to subscribe to the Vail MLS, they must also be a participant of another MLS.
