McDonough District Hospital

McDonough District Hospital is working with the McDonough County Health Department, McDonough County Emergency Services, and Disaster Agency during the COVID-19 crisis

New permanent building for drive-thru screening station

What started as a temporary solution will turn into a permanent fixture on the McDonough District Hospital campus. Following the August MDH Board of Directors meeting, the Board voted in favor of replacing the tent that currently serves as the drive-thru screening station with a permanent steel-frame building set to open later this year.



The current 40'x80' tent (rented out by MDH on a monthly basis), located in the south parking lot, became operational in late March. Inclement weather at times has forced the staff to move operations inside to either MDH or Health Services Building 2. The new steel-frame building, tentatively the same width but projected 20 feet longer, will have garage doors for entrances and exits, become climate controlled, and offer a permanent office area with restroom facilities for staff.

The current tent used for the drive-thru screening station has seen increased traffic in recent months. There were an average of 23 visits through the tent per day in June, 39 during July and so far 45 per day in August. The drive-thru screening station not only provides COVID-19 tests but the staff can also perform certain laboratory blood draws and will provide flu vaccinations this fall.

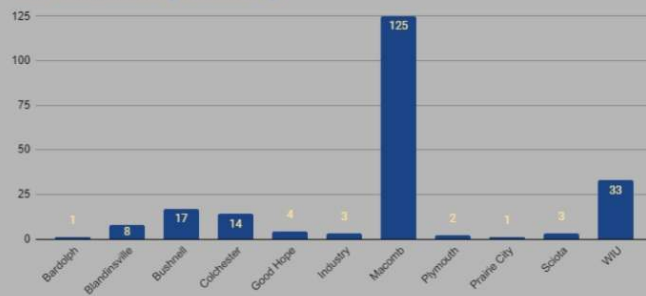

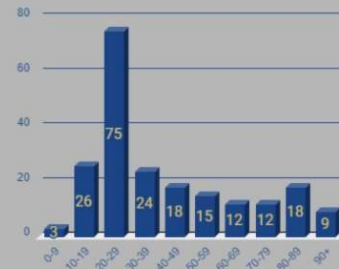

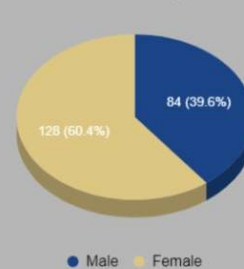
Case Breakdown by Community

10 things you can do to manage your health at home

If you have possible or confirmed COVID-19:

1. **Stay home** from work, school, and away from other public places. If you must go out, avoid using any kind of public transportation, ridesharing, or taxis.



2. **Monitor your symptoms** carefully. If your symptoms get worse, call your healthcare provider immediately.



3. **Get rest and stay hydrated.**



4. If you have a medical appointment, **call the healthcare provider** ahead of time and tell them that you have or may have COVID-19.



5. For medical emergencies, call 911 and **notify the dispatch personnel** that you have or may have COVID-19.



6. **Cover your cough and sneezes.**



7. **Wash your hands often** with soap and water for at least 20 seconds or clean your hands with an alcohol-based hand sanitizer that contains at least 60% alcohol.



8. As much as possible, **stay** in a specific room and **away from other people** in your home. Also, you should use a separate bathroom, if available. If you need to be around other people in or outside of the home, wear a facemask.



9. **Avoid sharing personal items** with other people in your household, like dishes, towels, and bedding.



10. **Clean all surfaces** that are touched often, like counters, tabletops, and doorknobs. Use household cleaning sprays or wipes according to the label instructions.

All employers now required to provide sexual harassment training

**ILLINOIS HUMAN RIGHTS ACT

SEXUAL HARASSMENT TRAINING



The Illinois Human Rights Act ("IHRA") has recent been amended and is now requiring: Illinois employers to provide annual sexual harassment prevention training by December 31, 2020 and annually thereafter. It does not matter how big or small your business is, you must provide sexual harassment training to all employees. The Illinois Department of Human Rights (IDHR) has a Power Point or PDF training model that you can use and includes a certificate for each employee to fill out upon completion. You can use their model or create your own training.

RESOLUTION 2020-01

A RESOLUTION SUPPORTING EXECUTIVE ORDER 2020-43 REGARDING FACE COVERINGS

WHEREAS, the novel coronavirus (COVID-19) is a respiratory disease that can result in serious illness or death and it is caused by a new strain of virus that has not previously been identified in humans and can easily spread from person to person; and

WHEREAS, Governor Pritzker has declared a state of emergency to harness resources across the state to slow the spread of the virus including, but not limited to, requiring face coverings in public places and in certain instances outdoors (Executive Order 2020-43); and

WHEREAS, the Centers for Disease Control and Prevention (CDC) has issued guidance to the public and employers to slow the spread of the virus including, but not limited to, encouraging individuals to wear face coverings and practice social distancing; and

WHEREAS, there has been a recent increase in confirmed cases within McDonough County; and

WHEREAS, the McDonough County Quality of Life Committee recognizes the importance and effectiveness of face coverings in helping to slow the spread of the virus; and

WHEREAS, the McDonough County Quality of Life Committee desires to assist in returning to economic stability, which can more likely be obtained if businesses can stay open and gradually return to full capacity, and understands that this may be dependent on slowing the spread of the virus; and

WHEREAS, the McDonough County Quality of Life Committee desires to do what it can to keep residents, visitors, business owners and front-line workers safe; and


WHEREAS, the McDonough County Quality of Life Committee emphasizes the personal responsibility of each individual to wear a face covering and believes doing so reflects a sign of respect for neighbors, front line and essential workers, and all residents and visitors

WHEREAS, the McDonough County Quality of Life Committee desires to provide leadership and support to implement the wearing of face coverings; and


NOW, THEREFORE, BE IT RESOLVED by the McDonough County Quality of Life Committee as follows:

1. The McDonough County Quality of Life Committee supports Executive Order 2020-43 requiring wearing of face coverings in any indoor public space and when outdoors and unable to maintain a distance of six feet or more from individuals who are not members of the same household.
 - Individuals are encouraged to implement their personal responsibility by wearing face coverings as required to help keep others safe both in public places and as appropriate outdoors and to eliminate putting businesses and law enforcement in the position of enforcing the standards
 - Businesses are encouraged to do their part in implementing the requirements so that customers feel safe that the expected protocols are in place.
 - In the rare instances where law enforcement is called upon for enforcement, the McDonough County Quality of Life Committee supports the approach of educating first and attempting to get voluntary compliance. Using law enforcement discretion, in instances where personal responsibility and voluntary compliance cannot be achieved and the law enforcement staff feels that enforcement is the best option in the circumstances, enforcement that is deemed necessary will be supported.

Child & Family Services child abuse resources

Dear Chamber of Commerce Member:

Keeping families at home during the COVID-19 pandemic has helped to protect children from infection. For some children, however, this has come at the cost of increased suffering from maltreatment – at the very time that children have been isolated from the teachers, coaches, friends or other trusted adults who might otherwise detect compromise to their safety and well-being. In fact, calls to report suspected child abuse and neglect have decreased in Illinois by 57% compared to the same time last year – mirroring data from across the country.

It is important for every person to:

- Take child abuse and neglect seriously;
- Be able to recognize it; and
- Know what to do next.

To ensure that everyone knows how to contact the Child Abuse and Neglect Hotline to report suspected child abuse or neglect, the Illinois Department of Children and Family Services has created a new **Protecting Children is a Responsibility we all Share** poster, which is attached. We ask that you please send the attached poster to your membership and urge them to print and display it in a high-traffic area seen by visitors and employees. If you would like additional posters to display in your front window so they can be seen by passers-by; or to distribute to businesses in your community, please email Linda Davis at Linda.D.Davis@illinois.gov or call 312-814-6847. Posters are free and are available in English, Spanish, Polish and Arabic.

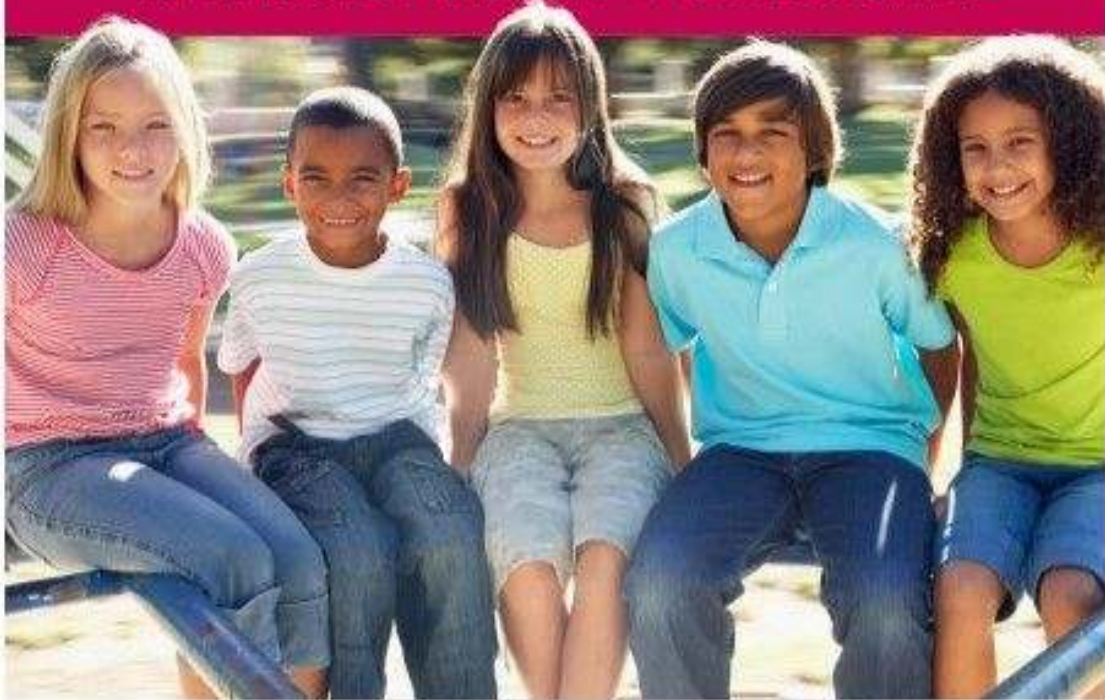

Amtrak to adding trains to WIU communities

Beginning this September 3, Amtrak is adding an additional coach to trains #380 and #383 providing service between Quincy and Chicago via Macomb, Galesburg and Princeton. Due to ridership declines Amtrak has previously reduced frequency and train length along the route. As ridership returns, Amtrak is monitoring travel demand and bookings. To accommodate increased travel Amtrak is adding a coach to the existing departures to better accommodate all those who want to travel, especially students at area colleges, and to continue to support economic activity in Illinois. Amtrak continues to adhere to enhanced cleaning protocols aboard trains, social distancing, half capacity trains, and cashless transactions.

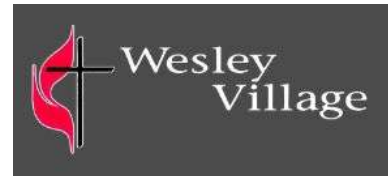

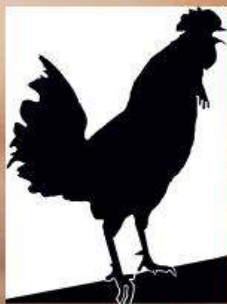

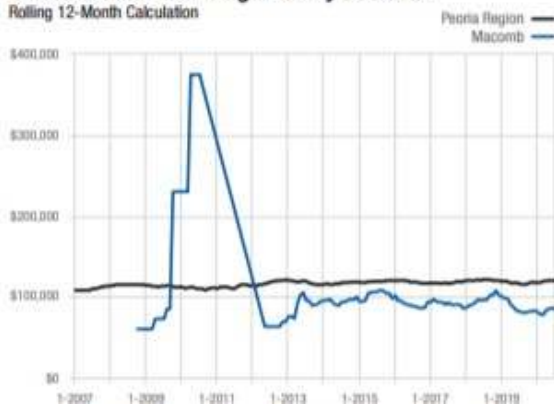
