Update from Supervisor Lynn Compton, District 4: Oceano, Nipomo, and Arroyo Grande

Happy November! I hope everyone had a very fun Halloween and is gearing up for a great Thanksgiving! With the recent rain and declaration of drought, I have received many questions about why water is released from Lopez Lake. The County has obligations for the release and the intent is to help all users of water in our community. There are four key reasons Lopez Dam releases water downstream:

1. The California Fish and Game Code, Section 5937, requires: "The owner of any dam shall allow sufficient water at all times to pass through a fishway, or in the absence of a fishway, allow sufficient water to pass over, around or through the dam, to keep in good condition any fish that may be planted or exist below the dam." Since Lopez Dam does not have a fishway (fish ladder), downstream releases are made through pipes that pass through the dam.

2. The Federal Endangered Species Act. Federal Law prohibits any action that would result in the "take" ("The term 'take' means to harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct."). Steelhead were declared a Threatened Species in 1995 and Arroyo Grande Creek supports a population of the fish. Shutting off downstream releases would dry up the upper part of the creek and result in harm to steelhead in the area, thereby violating federal law.

3. Downstream Water Rights. Landowners, primarily farmers, whose land abuts the creek have a legal right under section 10 of the California Constitution to the natural flow of water in the creek, so long as the farmers use the water for reasonable and beneficial uses. If flows from the dam are stopped, farmers and landowners in the upper portions of the Arroyo Grande Valley would not be able to exercise their water rights. In the winter, when flows in the creek are above the amount needed by the farmers, the "extra" water is stored in the reservoir above the dam.

4. In addition to the legal requirements, it is important to note that the water released from the dam increases the amount that recharges the groundwater basin below the dam. This groundwater is used by landowners as well as downstream municipalities in addition to supplies from Lopez Lake.

How much water is released downstream from Lopez Dam?

The Lopez Project was designed to produce a long term annual average of 8,730 acre feet water per year (an acrefoot of water is 325,851 gallons). Of this 8,730 acre feet, 4,530 is contracted to municipal users in the Five Cities and Avila Beach area, the remaining 4,200 acre feet is for downstream uses. When the watershed produces more than 8,730 acre feet in a given year, the excess is stored in the lake and used in vears when the watershed produces less than 8.730 acre feet. The rate at which water is released from the dam varies with the season. In winter months releases are reduced because downstream uses need less water, in summer releases increase to meet streamside and groundwater needs. In recent years, a typical winter release averages 3 cubic feet per second (1.9 million gallons or 5.95 acre feet per day), in the summer releases rise to as much 12 cubic feet per second (7.8 million gallons or 26

Update from Supervisor Dawn Ortiz-Legg, District 3: Avila Beach, Grover Beach, Pismo Beach, and San Luis Obispo

Happy Fall! I would like to share three major developments that impact the future of San Luis Obispo County, District 3:

The San Luis Valley Basin Groundwater Sustainability Plan (GSP) has been completed and scheduled for Board of Supervisors approval on December 7th. This document fulfills the GSP development requirement for the SLO Basin. The GSP describes and assesses the groundwater condition of the SLO Basin, develops quantifiable management objectives that account for the interests of the SLO Basin's beneficial groundwater uses and users, and identifies a group of projects and management actions that will allow the SLO Basin to achieve and maintain sustainability in the future.

Once approved by the SLO County Board of Supervisors, the SLOGSP will be delivered to the California Department of Water Resources for their review and approval.

The SLO Basin Groundwater Sustainability Plan (GSP) was developed by two Groundwater Sustainability Agencies (GSAs) formed by the County of San Luis Obispo (County GSA) and the City of San Luis Obispo (City GSA). The GSAs entered into a Memorandum of Agreement (MOA) for the purposes of coordinating preparation of a single GSP for the SLO Basin. The MOA also established the Groundwater Sustainability Commission (GSC), which serves as an advisory body to the GSAs consisting of representatives from the County GSA and the City GSA, as well as representatives from the other signatories to the MOA (i.e., Golden State Water Company (GSWC), Edna Valley Growers Mutual Water Company (EVGMWC), Edna Ranch Mutual Water Company (ERMWC), and Varian Ranch Mutual Water Company (VRMWC).

The GSP is a plan designed to meet goals to replenish the San Luis Valley basin by incorporating monitoring and measuring tools, increase technological efficiencies and investing in supplemental water sources, such as recycled water.

It may be important to remember the state of California did not have management plans for the past one hundred years, or since massive population and development growth took place. There were deals and exchanges but no monitoring and measuring.

To establish a path to a sustainable water basin is critical to the many valuable aspects of SLO County life – agricultural production, tourism, environmental integrity, home values and our collective best interest.

Their nine- to 10month program breaks down clients' triggers, helps them discover healthy coping mechanisms, and introduces them to habits and rhythms that sustain sober living. As the client moves through the program, they begin to look for sustainable housing and employment. After they graduate, they are able to move into Central Coast Rescue Mission's transition house across the street to offer more time to finish the final steps of their program.

Central Coast Rescue Mission receives thousands of pounds of excess food from local grocery stores that they redistribute to needy neighborhoods. They also have a weekly grocery outreach event with fresh produce and nutritional staples for low-income families on Santa Maria's west side. On Friday mornings, Central Coast Rescue Mission helps Cornerstone Church with their riverbed outreach, where they bag lunches and deliver them to the homeless. Their two big events are Thanksgiving and Christmas banquets on November 19th and December 17th, respectively. They serve a meal where each individual and family are



invited to celebrate within their family units in a way that dignifies their personhood. At the Christmas banquet, they also provide Christmas presents for the children. Central Coast Rescue Mission needs volunteers and financial donors to support their mission. City of Pismo Beach offering generous grants and scholarships for childcare centers and families

PISMO BEACH — The City of Pismo Beach is offering generous grants and scholarships for childcare centers and families in their city.

The Pismo Beach Childcare Assistance Grant will provide individual scholarships for supporting childcare payments from three to 12 months. The grant gives up to \$2,000 for a Pismo Beach resident, and the monthly amount may vary based on need and duration of assistance. There is \$20,000 available in this grant program.

The second grant opportunity, the Childcare Expansion and/or Reopening Grant Program, is available to pay the costs of certifications, regulatory requirements, or other physical improvements to reopen or expand childcare centers in the City of Pismo Beach. There are \$30,000 in funds available in



this program.

"Oftentimes the high cost of childcare can be a barrier for employees returning to work," said Pismo Beach City Manager Jim Lewis. "The City Council recognizes this and approved the Pismo Beach Childcare Assistance grant program funded by the American Rescue Plan Act—to help residents with the cost of childcare and expand capacity at Pismo Beach childcare facilities."

South County Chambers of Commerce will facilitate the program in partnership with the City of Pismo Beach. Scholarship and grant review panels will meet to review the applications and work with the City of Pismo Beach to ensure necessary documentation is received before notifying recipients and distributing funds.

acre feet per day).

Is there a plan to reduce releases if the water gets very low in the reservoir?

Yes. In August of 2021 the Board of Supervisors and all the agencies that receive water from Lopez Lake adopted the Low Reservoir Response Plan. As levels in the lake drop, reductions are made in both municipal deliveries and downstream releases. If the lake reaches 10,000 AF that will trigger substantial reductions in downstream releases. These reductions are a key part of the emergency drought response actions reflected in the Low Reservoir Response Plan.

Do other reservoirs make similar releases?

Yes. The Nacimiento Reservoir, operated by the Monterey County Water Resources Agency, for reasons similar to Lopez, releases a minimum of 60 cubic feet per second into the Nacimiento River, even during winter months. These minimum releases are a requirement of the Federal Endangered Species Act. In summer, when irrigation demands in the Salinas Valley increase, the releases increase substantially.

The Salinas Reservoir (Santa Margarita Lake), operated by the County of San Luis Obispo, is allowed to divert water to storage only when the Salinas River is flowing on the surface between the Dam and the confluence of the Salinas and Nacimiento Rivers, a distance of about 40 miles. This requirement is part of the water rights permit issued for the building of the dam in the 1940's and is intended to protect both downstream water rights and fish populations in the river.

Knowing You Matter Hosts 'Harvest of Hope' Fundraising Dinner

Local nonprofit brings hope to those affected by suicide and promotes community outreach for suicide prevention

Knowing You Matter, a local nonprofit that recently joined the Chamber, will host their first Harvest of Hope dinner and live and silent auction on November 20th at 4:30 pm at Thousand Hills Ranch in Pismo Beach.

The evening will be a chance to come together as a community to support an important cause while enjoying a traditional Santa Maria Style BBQ dinner, good company, and the opportunity to bid on one-of-a-kind goods and experiences. Live auction items feature a one-week stay at an Italian villa in Tuscany in addition to stays in Cabo, Maui, and a Cayucos vintage trailer getaway.

"We are excited to kick off the holiday season by coming together to celebrate life and promote our mission to make sure that everyone knows they matter," said Cindy Kullman, founder of Knowing You Matter. "Losing our son Mikey to suicide was devastating for our family. The legacy of Mikey's love will live on through our vision to make a difference in our community by raising awareness not only about suicide prevention, but the importance of emotional health and wellness. We are dedicated to erasing the stigma surrounding this difficult topic and bringing hope to those affected by suicide."

Knowing You Matter partners with local community resources to fulfill their mission. In September, they hosted a conference in honor of suicide prevention and awareness month that drew more than 300 attendees. The event included a resource fair with 18 organizations represented. Their Hope Bag Project supports those who have lost a loved one to suicide, people who have attempted suicide, and those considering suicide. 








Diablo Canyon Decommissioning Update: Inviting Public Input

I wanted to give you an update on the Diablo Canyon Power Plant Decommissioning permitting process.

On October 28th, 2021, the County of San Luis Obispo's Planning Department issued a letter of application acceptance to Pacific Gas & Electric "PG&E". What that means is the PG&E application to decommission Diablo Canyon Nuclear Power Plant was deemed "complete". To get to this point required months of review by our specialized County decommissioning staff, County Counsel and by outside agencies. The next step is for the County to issue the Notice of Preparation (NOP) informing agencies, organizations, and the public of the County's intent to prepare an Environmental Impact Report (EIR) and to solicit agency, organization, and public input on the scope and content of the Environmental Impact Report. To receive public comment, the County will hold five virtual scoping meetings and the dates and times are as follows:

- Tuesday, November 9th: 10:00 a.m. and 6:00 p.m.
- Wednesday, December 1: 10:00 a.m. and 6:00 p.m.
- Saturday, December 4: 2:00 p.m.



Lastly, the County Redistricting process is in high gear and the boundary lines of our Supervisorial Districts look to be changing. Interestingly, the SLO County population only had an increase of 9,631 new citizens. Due to this small increase there is no legal requirement for any of the supervisor district boundaries to be changed. However, for reasons otherwise, changes are indeed afoot. These may be extremely different boundaries and some citizens and candidates will love the changes, while many others may not be as thrilled as we head into the 2022 elections. The next Redistricting meeting will be November 19 at the Board of Supervisors Chambers at 1055 Monterey Street.
