# Applications now open for local startups to compete for \$100,000+ in equity-backed funding

SAN LUIS OBISPO—Cal Poly's Center for Innovation and Entrepreneurship (CIE) Small Business Development Center (SBDC) opened applications for Central California startups to participate in Angel-Con 2023—a competition in which local companies compete for \$100,000+ in equity-backed funding.

Central California-based startups will have the opportunity to join the ranks of Tallyfor, AcreCloud, and Novocuff, who collectively won \$350,000 and received close to \$1M in follow-up investments. Applicants must be based in Central California, demonstrate a completed proof of concept with an MVP and/or early revenue,





have potential for scalability and high growth, as well as have a strong founding team.

"AngelCon has become a keystone event for the Central California business community," says CIE Economic Development Director Judy Mahan. "This is our sixth annual event; we originally launched AngelCon in 2018, hoping to engage with people who would be interested in learning to invest in tech startups. The outcomes have surpassed our expectations, we've connected with close to 150 new angel inves-

tors counting this year's fund and provided access to more than \$19M in capital to 26 startups. It's been very rewarding to act as a conduit connecting new angels to local deal

flow, as well as showcase the amazing pipeline of innovative startups launching and growing in our County."

This event is propelled by a dedicated group of angel investors interested in early-stage startups in exchange for ownership equity or convertible debt. These investors have strong involvement in the evaluation, due diligence, and selection process of AngelCon applicants leading up to the live, hybrid-event,

## Update from Supervisor Jimmy Paulding, District 4: Nipomo, Arroyo Grande, Oceano, Huasna, Edna Valley, California Valley, and unincorporated portions of SLO

I hope this finds you well. After the severe storms we had in January, I am hopeful that February brings more modest weather. The most severe storm last month hit less than a week after I was sworn in and caused significant damage and disruption to residents and businesses throughout the County. The storm destroyed bridges, flooded homes, and caused the Arroyo Grande Creek Levee to breech. The County has preliminarily estimated more than \$18M in road damages, \$16M in flood control damages, and \$82k in county facilities damages.

Fortunately, there are resources available to help those in our county recover from storm damage. On January 17, California's Emergency Declaration was amended to include San Luis Obispo County, which allows those impacted by the storm to qualify for individual financial assistance from FEMA. If your home was damaged by the recent storms, please visit disasterassistance.gov or call 800-621-3362 to apply for relief.

Relief programs are also available for business owners. farmers, and ranchers. Business owners may apply for lowinterest business disaster loans and economic injury disaster loans through the federal **Small Business Administration** by visiting their website at disasterloanassistance.sba.gov or calling 800-659-2955. If your farm or ranch land was impacted, various relief programs are available from the USDA Farm Service Agency office in Templeton by calling 805-434-0396 or send an email to jeffrey.sledd@usda.gov.

In partnership with FEMA and Cal OES, the County Office of Emergency Services opened a Disaster Recovery Center (DRC) on January 24. The DRC is open seven days a week from 8:00 AM to 7:00 PM at the Veterans Memorial Building, 801 Grand Ave in San Luis Obispo, until February 7. Representa-

tives from a consortium of federal, state, and local departments and agencies are available to help as well as nonprofit providers. Any residents who need transportation to the DRC can call County

January's storm was a huge challenge, but I am extremely proud of our staff and leaders who stepped up and met that challenge head on. It has been a LONG time since our community has experienced an event of this magnitude. As the situation was rapidly evolving staff was tasked with quickly adjusting their direction to meet the changing needs of the community. We have now entered the recovery phase of the process and the Disaster Recovery Center at the SLO Veteran's Hall located at 801 Grand Ave. in San Luis Obispo is now open. FEMA, along with state agencies such as DMV and Franchise Tax Bureau, along with county resources and nonprofits, are present and ready to assist and guide our neighbors through their recovery process. "resolutions" for the county. With the swearing in of the new Board on the 3rd of January we are already looking for ways to work towards achieving those resolutions. Last week at our Board of Supervisor's meeting the board identified their collective priorities for the fiscal year 2023-2024. Top of the list of issues identified by the Board are to address homelessness within the community, followed by behavioral health services and housing. Our recognition of specific priorities does not diminish the importance of other issues within the community and will not reduce resources delegated to other already established services. These priorities will simply serve as a roadmap to guide staff and the Board's efforts as we move forward this year.

Also during our most recent Board meeting, members were assigned or reassigned to various committees and commissions. Collectively the Board of

I am happy to report that South San Luis Obispo County Sanitation District had no significant issues during the storms and no failures at the plant. Further, our redundancy project is still on time and on budget, and surprisingly only lost two construction days to the weather. The project should be completed in June.

Our beloved Swinging Bridge was damaged during the storm by a large piece of debris in the creek that struck one of the bridge supports. It is closed indefinitely. Staff is assessing the damage and deciding whether the planned work that was already going to happen is still possible as designed. Stay tuned for more info in the coming weeks as we figure out the particulars.

I am heartened by the level of community support I have witnessed during these storm events. City Managers and City staffs all over the county were running on fumes at all hours trying to keep everyone safe and infrastructure operational. Thank a city/county worker the next time you see them out on the streets, or a City official at your next service club meeting. Truly, they are heroes.

#### Pismo Beach News

The winter storms made a huge impact on our water supply. Lake Lopez is now over 50% full, and we expect more water delivered by the State Water Project. The ground water basins will also be much improved. While our supply is much improved, we still need to conserve.

The storms also caused considerable erosion on our bluffs when a combination of high surf and King Tides pounded our coastline. Our damage estimates are

significant, and we will try to find funding to make repairs. Fortunately, the rest of the City did pretty well in the storms, and we welcomed the dry weather afterwards.

In early February, our Council will meet to discuss our goals for the coming year. We solicited feedback from our residents and, not surprisingly, water was a significant concern. We are already working with Arroyo Grande and Grover Beach on a water recycling project which fits nicely with that feedback.

We are also continuing with a new public safety complex with a new police station and fire station on Bello Street; new park equipment; James Way beautification; and repaving streets so our plate is already full.

#### **History of Fashions for a Purpose**

Backed by The Mary Kay Foundation, Kimberley Victor founded FFAP in 2015 after moving to Nipomo. A successful businesswoman and Mary Kay Consultant, Kimberley was spurred into action after one of her consultants lost her life in a domestic violence situation. A survivor herself, Kimberley knew she had to act. Two days later, Fashions for a Purpose (FFAP) was born.

During its first event, FFAP raised and donated \$3,040 to local domestic violence causes. In 2021 FFAP had raised \$15,000 and was recognized as the top fundraising body in The Mary Kay Foundation. Kimberley and a small volunteer committee spend all year planning and hosting the annual fashion fundraising event. Since its inception in 2015, Fashions for a Purpose (FFAP) has raised over \$200,000.

OES at (805) 781-5678 to arrange transportation.

I am incredibly grateful for the hard work of our first responders and County staff from Public Works, OES, and other departments who in many cases worked around the clock to keep our community safe. I am also encouraged by the way many members of our community stepped up to help their neighbors during this challenging time. This storm has once again reminded us that we are stronger as a community when we work together.

January 24 marked the Board of Su-

pervisor's first substantive meeting since I was sworn into office. Of note, the Board provided direction on our County's budget goals and policy priorities for fiscal year 2023-24 which begins in July. For FY 23-24, the Board established the County's first-tier priorities as homelessness, behavioral health services, and housing, and its second-tier priorities as storm recovery, economic development, and water resiliency. Additionally, the Board clarified the County's ongoing priorities as meeting legal mandates, debt service requirements, and public safety. At the meeting, the Board also formally designated a primary supervisor for areas left without representation because of redistricting. I am honored to formally represent and serve the

community of Oceano going forward.

Now that I have taken office, I have begun scheduling weekly office hours in South County for constituents to meet with me and share their concerns and priorities. In Nipomo, my office hours are at the Nipomo Library from 10 am to noon on the first, second, and fourth Thursday. In Arroyo Grande, my office hours are at the Arroyo Grande Library from 1:30-3:30 PM on the second and fourth Thursday. 






## SLO County businesses eligible to apply for SBA assistance

SAN LUIS OBISPO COUNTY—San Luis Obispo County business owners affected by the recent storms are now eligible to apply for financial assistance through the Small Business Administration (SBA). SBA provides low-interest, long-term loans for physical and economic damage caused by a declared disaster.

Business owners who incurred financial losses due to storm damage are encouraged to apply for assistance at <u>disasterloanassistance.sba.gov</u> or by calling 1-800-659-2955 to request an application.

SBA makes physical disaster loans of up to \$2 million to qualified businesses or most private nonprofit organizations. These loan proceeds may be used for repair or replacement of the following:

- Real property
- Machinery
- Equipment
- Fixtures
- Inventory
- Leasehold improvements



#### U.S. Small Business Administration

The SBA Business Physical Disaster Loan covers disaster losses not fully covered by insurance. If you are required to apply insurance proceeds to an outstanding mortgage on the damaged property, you can include that amount in your disaster loan application.

If you make improvements that help reduce the risk of future property damage caused by a similar disaster, you may be eligible for up to a 20 percent loan amount increase above the real estate damage, as verified by the SBA.

You may not use the disaster loan to upgrade or expand a business, except as required by building codes.

A business of any size or most private nonprofit organizations, that are located in a declared disaster area and have incurred damage during the disaster, may apply for a loan to help replace damaged property or restore its predisaster condition.

The interest rate will not exceed four percent if you cannot obtain credit elsewhere. For businesses and nonprofit organizations with credit available elsewhere, the interest rate will not exceed eight percent. SBA determines whether the applicant has credit available elsewhere. Repayment terms can be up to 30 years, depending on your ability to repay the loan.

The SBA opened a local assistance center on January 24th to help local residents and businesses start their disaster recovery loan application process. In addition, other agencies such as FEMA will be on site to provide information on available services. The center is located at the SLO Veterans Hall at 801 Grand Ave. in San Luis Obispo and is open Monday through Sunday from 8 am to 7 pm. 




