## Women's Business Center Launches Online Spanish Entrepreneurship Course starting July 11th

The Women's Business Center of San Luis Obispo County is proud to announce it will bring back its entrepreneurial training course, "Sonando y Empezando," this month. In this eight-part program followed by four mentoring sessions, students learn how to turn a business idea into a simple business plan while taking action to define their business earning potential.

The first step in the entrepreneurial journey is to discover who you are and how to leverage your unique mix of talents to build a viable business. The program aims to explore "why" becoming an entrepreneur might be the right next step for you and how that can help you discover and define your business vision, mission, and values. And learning to create a simple income and expense budget while managing money with the resources available adds to the vital skillset of any entrepreneur.

Students also gain knowledge on how to align

their product or service, pricing, and offer to their perfect paying customer's needs, wants, and desires. They learn how to build their brand story and spread the word to build momentum to help gain awareness, shift their mindset, and work through the challenges and obstacles getting in the way. One of the most valuable aspects of this program is the opportunity to connect with a community of aspiring entrepreneurs and smallbusiness owners. In the end, students graduate with a completed simple business plan.

This course is valued at \$1,895 and is being offered for a \$100 deposit—refundable upon graduation—or you may donate it to support future aspiring entrepreneurs.

Classes will be led by Gabe Quiroz online on Tuesdays over 12 weeks. Classes begin on July 11th at 9 AM. Class runs from 9 AM to 11:30 AM each week; registration is open at the Women's Business Center's website, <u>mcscorp.org</u>.

Chamber Business of the Month for July 2023: Central Coast Community Energy (3CE)

Congrats to Central Coast Community Energy (3CE) as the Chamber's Business of the Month for July 2023!

3CE is a public agency that procures electricity from clean and renewable energy resources. Thirty-five communities joined Central Coast Community Energy (3CE) with the shared goal of gaining more control over their electricity needs: to reduce greenhouse gas emissions, support the growth of clean and renewable energy, and access additional economic and environmental benefits. 3CE follows the Community Choice Aggregator or "CCA" model, a community-focused, not-forprofit model that allows for greater commitment to clean and renewable energy while supporting community reinvestment for affordable and fair rates and equitable access to cleanenergy resources.

3CE serves 95% of the population



throughout Monterey, San Benito, Santa Cruz, San Luis Obispo, and Santa Barbara counties. Many community members are 3CE customers without realizing it. South San Luis Obispo County communities that are currently enrolled include Arroyo Grande, Grover Beach, and Pismo Beach. San Luis Obispo and Morro Bay are also enrolled.

As a 3CE customer, your utility (PG&E) continues delivering power as well as maintaining electric infrastructure and billing, but 3CE and the communities they serve now manage where (local vs. California vs. out-ofstate) and how (solar, wind, geothermal, etc.) electricity is generated. With no investors or shareholders to pass profits on to, together with our customers, 3CE chooses how best to reinvest in the Central Coast community. PG&E continues charging for Transmission and Distribution, while 3CE now charges for Electric Generation (formerly part of PG&E or SCE Bundled Service costs).

### Update from Supervisor Jimmy Paulding, District 4: Nipomo, Arroyo Grande, Oceano, Huasna, Edna Valley, California Valley, and unincorporated portions of SLO

Happy summer South County! Last month I had the pleasure of speaking at the Chambers' State of South County event at Vespera Resort in Pismo Beach. Now that I am six months into my term, I would like to give you an update on what my colleagues on the Board of Supervisors and I have accomplished so far this year, what work is still in progress, and share a little bit about some of our Board's upcoming goals and priorities.

What we've accomplished so far: · Approved a balanced budget for fiscal year 2023/24. You can read more about the budget at slocounty.ca.gov/ budget.

· Fully funded public safety services and adopted a strategic plan for our fire department.

 Lowered the campaign contribution limit for local elections from \$25,000 per donor to \$5,500, reducing the influence of big money in our local elections. Restored fair district maps for future SLO County elections. Our Board also formalized representation of the communities that were left without a supervisor during the 2021 redistricting pro-

cess. Until 2026, Supervisor Gibson will represent Los Osos and Morro Bay, while I will represent Oceano.

· Joined Central Coast Community Energy, saving the County over \$1.1 million per year on its own electricity bill and \$26 million annually for residents and businesses in the unincorporated areas starting in 2025.

· Advanced diversity, equity and inclusion at the County. For the first time in SLO County's history, the Board passed a resolution recognizing June as LGBTQ+ Pride Month. We also adopted a resolution condemning racism, bigotry, and hate speech in our community.

 Approved the final phase of the Trilogy at Monarch Dunes development in Nipomo with a fully funded paved perimeter trail. The developer initially offered to construct portions of the perimeter trail in lieu of paying the required \$1.2 million in Quimby fees but the Board was able to get the developer to construct the whole trail (estimated at a cost of \$3 million) in lieu of the fees. This was a good deal for the community, which will soon have a fully paved, publicly accessible perimeter trail at Trilogy in Nipomo.

· Moved forward with starting the process of rejoining the Integrated Waste Management Authority, which will strengthen regional collaboration and reduce costs in garbage rates.

· Advocated for the needs of our growing population of older adults. Our Public Health staff secured a grant for a de-

It's been a busy year so far; therefore, as our nation's birthday comes, it's time for family, fun, and rest before we head into the second half of 2023.



We expect about 18 months for construction with completion around the end of 2024 to early 2025. We look forward to the additional rooms, visitors, and additional TOT this project will bring.

~ The Five Cities Fire Authority Board held its first meeting. Grover Beach Council Member Daniel Rushing was selected as Chair with Arroyo Grande Council Member Lan George as Vice Chair and Grover Beach City Manager Matt Bronson as "CEO" or Lead CM for

the first one-year term of this Board. They also adopted a budget, approved the services and liabilities agreements with OCSD, and issued PO's for muchneeded equipment.

This project is intended to create a sense of place for residents and an enticement to live and shop within their community while welcoming visitors to our City.

mentia and "healthy brains" initiative countywide, while our Department of Social Services staff secured a grant to develop a county master plan on aging with an ad hoc committee of the Adult Services Policy Council as the steering committee—led by members of the group I helped convene over a year ago who published the report titled "High Value Opportunities for Improving the Lives of Older Adults in SLO County."

Some key objectives still in progress: • Improving public safety in South County by building the long-promised Sheriff substation in Nipomo. Thanks to the support of my colleagues and Sheriff Parkinson, \$1.2 million was allocated in next year's budget to begin the design process of this facility in Nipomo.

• Implementing the Countywide Plan to Address Homelessness. After the Board identified housing and homelessness as one of our tier one priorities for the year, the County increased funding for homelessness services by \$1.8 million for fiscal year 2023/24. Plus, our \$13.4 million grant application to build an 80bed shelter adjacent to the County's Department of Social Services building in San Luis Obispo was approved by the California Interagency Council on Homelessness on June 14. This is great news! • Advancing a Central Coast desalinization project through our SLO County-led

effort to study and develop a <u>regional</u> <u>desalination plant</u> in collaboration with 16 other agencies. • Expanding the County's grant capaci-

ty. The Board allocated \$250,000 in next year's budget to fund the resources necessary to pursue key federal and state grant opportunities. By using innovative funding strategies and leveraging grants, we can advance our strategic priorities without impacting baseline service delivery.  Improving the Nipomo Community Park by adding a multi-use perimeter trail and a disc golf course. I continue to work with staff and community partners to advance these projects. The grand opening of the Nipomo Skate Park earlier this year was a success—the park is heavily used by kiddos and adults alike!
Improving our Community Advisory Councils. Supervisor Ortiz-Legg and I formed an ad-hoc committee to study and develop recommendations for how to improve the effectiveness of our community advisory councils. Our efforts will be completed over the next two months.

• Advancing infrastructure improvements in Oceano. Priorities include AG Creek Levee improvements, "safe routes for all"/sidewalk improvement projects, a Pier Avenue multi-modal study, adding a crosswalk on Highway 1, and addressing traffic congestion at Halcyon and Highway 1 by advancing the design of a new traffic signal or roundabout project.

• Addressing gaps and deficiencies in mental and behavioral health services. The Board recently approved the Behavioral Health Department's development of a strategic plan to identify gaps in the behavioral health services continuum of care and identify new goals and strategies to improve County services.

• **Reforming cannabis regulations.** At our June 20th meeting, the Board directed staff to report back to the Board with regulatory, tax, and fee policy recommendations to improve the viability of our legal cannabis industry, which has been a financially losing proposition for the County, and ensure the County remains in a strong fiscal position.

• Improving Planning and Building Department services. Utilizing Lean Six Sigma, which is intended to improve processes and create efficiencies within an organization, Supervisor Ortiz-Legg and I, along with our CAO and the Planning and Building Director, will champiBoys & Girls Club of South SLO County Solstice Publishing LLC Sunrise Terrace Mobilehome Park Assoc. on process improvements intended to reduce permit processing times and increase customer service delivery.

• Advancing housing policy by supporting the completion and implementation of Regional Housing Compact, <u>Housing</u> and Infrastructure Plan, and <u>Regional</u> <u>Transportation Plan</u> with our partners at the <u>San Luis Obispo Council of Govern-</u> ments, <u>Regional Transportation Authori-</u> ty, <u>REACH</u>, and the seven cities.

• Working to study and invest in infrastructure to support offshore wind development, broadband, and childcare as core County economic development initiatives as well as continue to study future opportunities related to Diablo Canyon, the Phillips 66 Santa Maria oil refinery, and the Oceano Dunes State Vehicular Recreation Area.  Initiating the process to repair roads and infrastructure damaged by the January, February, and March storms. We were hit with a dozen atmospheric rivers resulting in record-breaking rainfall and an unprecedented amount of damage in our county. Our Public Works team has identified 595 cleanup and repair locations including 287 roads requiring debris cleaning, 109 locations requiring emergency repairs, and 199 locations requiring permanent repairs. The total estimated cost of repair to all facilities and infrastructure is \$36 million. FEMA is expected to reimburse at least 75% of our repair costs but we are assuming only 66% reimbursement to budget for costs conservatively. Funding for our share will come from a combination of loans and general fund reserves.

Trinidad/Klamath Redwoods on the north coast. On September 30, 2021, the California State Park and Recreation Commission voted unanimously to change the name of Patrick's Point State Park to Sue-meg State Park, named by the Yurok tribe, who are the original descendants and owners of this stunning region. Sue-meg is the first CA State Park that is also now co-managed by the tribe, the Yurok. This relationship has resulted in the adoption of exhibits, tribe park rangers, and sharing of their practices of policies that respect their heritage. It also provides rights to access the park for ceremonies, gatherings, and other tribal activities. That wasn't the case in the past, and it is an exciting success so far!

This matters to us because the Oceano Stewardship Study highlights the need for tribal consultation as one of the many perspectives for the future. On page 2 is a photo highlighting my visit, which makes me very excited to work on all our park resources for you, your family, and our valuable visitors to our beautiful County.
