PCA 2021- 2022 PRIORITY LEGISLATION:

House Bill 171 of 2021:

An Act limiting restrictive covenants in health care practitioner employment agreements.

House Bill 173 of 2021:

An Act amending Title 40 (Insurance) of the Pennsylvania Consolidated Statutes, in special provisions relating to particular classes of insurers, providing for nondiscrimination by payers in health care benefit plans.

House Bill 225 of 2021:

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, further providing for definitions, for responsibilities of managed care plans, providing for preauthorization standards and for preauthorization costs, and providing for preauthorization and adverse determinations, for appeals, for uniform preauthorization form, for preauthorization exemptions.

House Bill 325 of 2021:

Advisory Opinions from Licensing Boards

House Bill 916 of 2021:

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in casualty insurance, providing for coverage for nonopioid pain management care.
