CHAIR'S MESSAGE

So where is the recession? I mean that sincerely. I know about the GDP trends, inflation, rising interest rates, massive layoffs in the tech sector and elsewhere, and I have read some of what the economists are writing. I particularly like Anirban Basu at Sage Economics. You can find his work on Substack and, if tradition continues, you can see him as the keynote speaker each year at the Washington County, Md. Economic Summit. Anirban makes sense and he makes me laugh; a combination I find irresistible in a typically dry topic like economics.

Basu and - pick your cast of talking heads on cable news - are generally concerned about recession. At least that's the case when the talking heads take a break from blaming the other political party for 'the shape our economy is in.' Well, what shape is our economy in? To a lay person like me it's rather hard to tell these days. There are certainly indicators that would suggest the recession is already here. However, when I talk to you, the Cumberland Valley business community, I hear from employers concerned about a labor shortage coupled with a record demand for goods and services. I hear talk of burnout and difficulty balancing the requirements of your career and the needs of your family. It's certainly no different in my business. I suppose both sides of the proverbial economic coin are real. I have no idea which side of that coin we will identify with when we close the books on the fourth quarter of 2023.

What I do know is that it doesn't look much like a recession at the local level right now. I hope that perception holds true. I also know that our economy is diverse, resourceful and resilient thanks to the generations of leaders that have come before us and those who propel us forward today. If recession does come, we are well positioned to weather it and recover quickly. Our labor force is hard-working and invested in making the Cumberland Valley a success. Our strength is our people. The CVBA is here, working alongside all of you, to make our economy strong. We are here to unite the business community and serve as a catalyst for collaboration.

Are you concerned about a possible recession? Don't focus on national trends and cable news. Find out what's happening right here and now in your circle of influence. Consider using your CVBA membership to share challenges with your peers in the business community. Ask for advice and offer suggestions to others. You can do this by attending mixers and events where you'll meet new people and expand your professional network. You might even make a couple new friends in the process. Healthy Communities Partnership of Greater Franklin County (HCP) began in 1993 when the Franklin County Health Care Consortium was founded by a passionate group of community leaders concerned about the overall health in Franklin County.

HCP is comprised of representatives from healthcare, human service agencies, government, education, faith and business communities.

For more than 10 years, HCP has hosted the Go Girls Go! program that works to educate and empower young girls in grades 4 to 6 improve their self-esteem, set goals and build friendships. The initiative also helps to increase their physical activity at a time when many girls drop out of organized sports and become sedentary. Mentors support the group during lessons and running activities while focusing on motivating and providing words of encouragement.

Recently, a former Go Girls Go! participant shared her story: "I used to be part of Go Girls Go in sixth grade. Now I am a senior and I love running. I currently run competitively in my high school



track and field team. I plan on still competing once I am in college. I want to help other girls to be more experienced in running and to enjoy it as much as I did."

picnics and weddings as well.

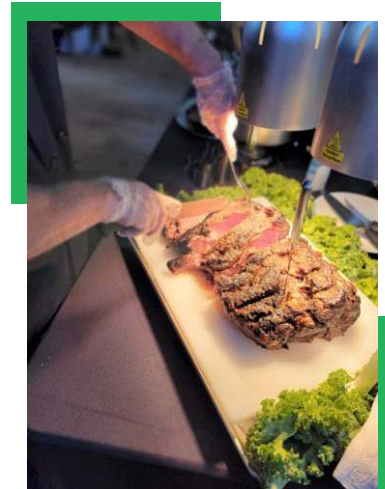
Hickory Ridge recently participated in the Chili-Q competition at IceFest. We were proud to support the event and win second place for both our chili and our pork bbq!

CHAMBERSBURG CIVIL WAR SEMINARS & TOURS PREPARES FOR 2023 SEASON

History enthusiasts from across the United States and Canada plan to attend three in-person conferences and more than a dozen virtual history talks hosted by Chambersburg Civil War Seminars & Tours, a division of the Chambersburg Chamber.

The first in-person conference will be held in Williamsburg, Va. called "Williamsburg Trifecta Tour." From April 27 - 30, guests will focus on the Revolutionary War, the Civil War and World War II. Six expert historians will cover diverse historical sites on the Virginia Peninsula.

The cost to attend is \$6 per HISTORYtalk and guests are sent the Zoom confirmation details after registering. Talks begin at 7 p.m. EST and include a question and answer period following the presentation.

Chambersburg Civil War Seminars & Tours began in 1989 and are held in partnership with historian Eric Wittenberg. 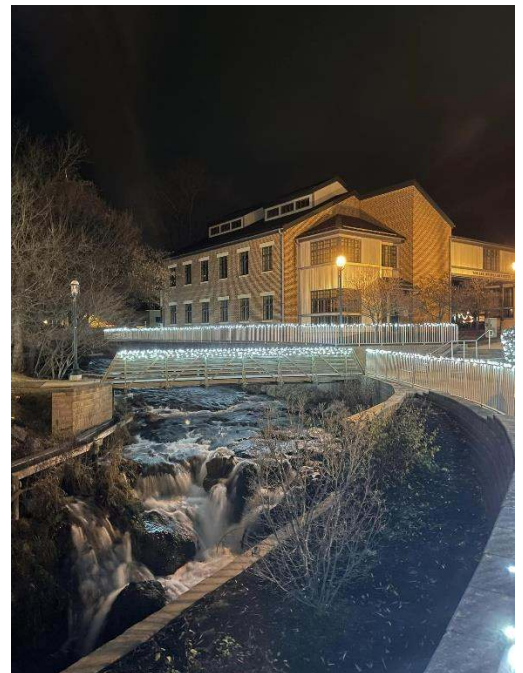
