

# N.C. A&T Bioengineering **Researcher Aims** to Develop Mini-brain in Fight Against Alzheimer's Disease



North Carolina Agricultural and Technical State University (NC A&T) Bioengineering Professor Yeoheung Yun, Ph.D., was awarded \$1.43 million from the National Institutes of Health (NIH) to develop a functional mini-brain model in the fight against Alzheimer's Disease (AD). Yun's team of highly qualified clinician experts in brain disease and immunology and a scientist in iPSC-derived call technology will create a mini-brain model by designing a "tissue construct platform" to replicate three areas of entry for Alzheimer's-combating drugs. <u>Click here</u> for full article.
