      1. The cash balance at NCDOT is an issue and resulted in approximately 900 projects across the state to be stopped.
      2. There are at least two bills being drafted to assist the cash balance crisis.
        - a. Concern was expressed over the potential State Auditor oversight in one of the bills that could slow the process of getting funds to NCDOT.
        - b. The best approach for PEFs to express concern to the NCGA is to tie the cash balance crisis to job layoffs.
