We are very excited to announce that Bill 37 received a second reading in the Legislature. On October 21, 2020, Service Alberta Minister Nate Glubish tabled Bill 37, the Prompt Payment and Construction Lien Act, which if passed

will make the first substantial amendments to Alberta's Builders Lien Act in almost twenty years. The Alberta Legislature will debate these amendments in the Fall 2020 session, develop detailed Regulations to accompany the amended Act, and expects the amended Act to come into force in July 2021. Terry Milot has been working tirelessly on this initiative for the past seven years and should be congratulated for his tenacious efforts.

We will be having a Ways & Means meeting on November 6th. The meetings agenda includes such things as a first pass on the proposed 2021 Budget as well as discussions and review of our Associations By-Laws.

We should also mention that we have purchased a new Association Management System (AMS) which will give our members the opportunity to update their own information, register for events, pay invoices and market their companies. With this new system comes a new website and so we would kindly ask that you bear with us as we populate all of the information. In addition, the ECAA on line Ethics course is also getting refreshed and updated.

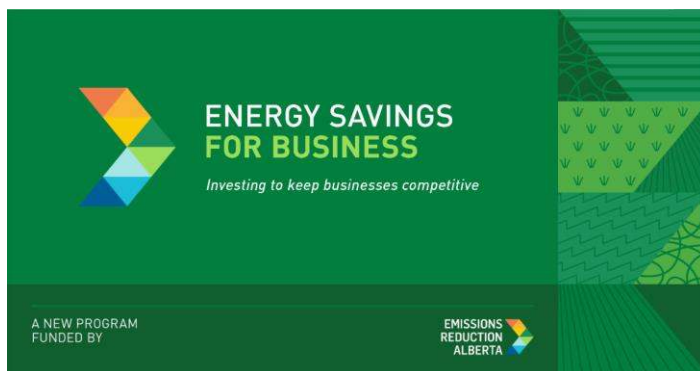

The Government of Alberta announced further emissions reduction initiatives

leveraging TIER funds. Emissions Reductions Alberta (ERA) will be rolling out a new [Energy Savings for Business Program](#), with up to [\\$55 million in funding](#). Messages directly from ERA are that the program will help accelerate the uptake of commercially available energy efficiency technologies, leading to operational efficiencies and cost reductions for small and medium-sized industrial and commercial facilities. The program objectives

are to stimulate investment, create jobs and address longer-term environmental sustainability

priorities. Through this program, businesses such as manufacturing facilities, agricultural operations, office buildings and fabrication shops can cut costs and reduce emissions by adopting modern building systems and updating facility operations, enabling smarter energy use and less waste. The projects in this program are intended to help re-invigorate the economy, while helping businesses become more competitive, hire more staff, and grow their operations. The projects will also rely on local contractors and a skilled workforce, including HVAC businesses, insulation companies, solar installers and electricians, to name a few. Applications are expected to open in January 2021 for businesses to submit their eligible projects for pre-approval. - Amy Roesler.
