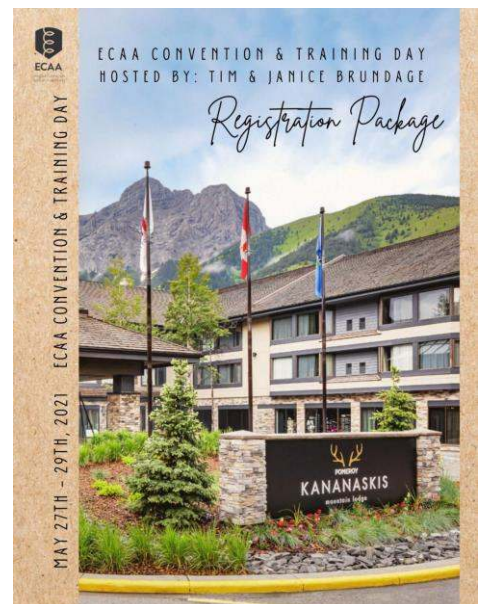

Have your say about changes to the Occupational Health and Safety Code.

Alberta’s government continues to update and improve occupational health and safety laws to make them easier to understand and apply for employers and workers. This will help them achieve better workplace health and safety outcomes. You can help us by providing your input on proposed changes to the Occupational Health and Safety Code (OHS Code).

The OHS Code has not been extensively updated since 2009 and changes are overdue. By reviewing the OHS Code, Alberta’s government wants to ensure health and safety rules keep pace with changes to workplaces, standards, new best practices and technological advances. The review will also help streamline and simplify OHS Code requirements.

This is the first year of the [three-year review plan](#) for the OHS Code. This year, we are reviewing changes required by the recently-passed Ensuring Safety and Cutting Red Tape Act. We are also reviewing parts of the OHS Code that require the most immediate updates. We encourage you to provide your input on proposed changes to the OHS Code by filling out the [online survey](#). You may fill out all parts of the survey or only those that interest you. **Please provide your input by May 10, 2021.**

Thank you in advance for participating in the survey. Your input will help us update OHS Code rules, making them easier to understand and follow and helping ensure Albertans make it home safely from work each day.

TAKE THIS SURVEY

The Government of Alberta introduced changes to Prompt Payment Legislation. While these changes were anticipated and for the most part welcome, Alberta Infrastructure (Public Works) projects will remain outside of the prompt payment Act. That will be a fight for another day. Another outstanding issue is grandfathering of existing contracts once the legislation is enacted. ATCC has been pushing for 1 year max. General Contractor's have asked for 5.

In addition to the Amendments, a new timeline for Enactment of the Bill was also provided (but was not included in the fact sheet). Development of a Government Of Alberta (GOA) Request For Proposal for appointment of authorized Nominating Authorities (NA) will remain the same with a goal to have at least one NA in place by July 01. 2021. This will include having a roster of qualified adjudicators also appointed by this time. The GOA will then spend the next 4 months introducing the concepts and nuances of operating within the legislation to the stakeholders with the intent of enacting the legislation in October 2021.

Your ATCC executive continues to push toward the development of an industry coalition Nominating Authority with the goal to have a GOA authorized NA operational by July. To date we have commitments from ATCC, ACA, AUMA, and Consulting Engineers of Alberta. We learned yesterday that BILD (residential) will not sign the Memorandum Of Understanding and the Consulting Architects of Alberta are non-committal. We anticipate having to proceed without further delay.

Builders Lien Act Amendments Fact Sheet - April 2021

The Government of Canada is transforming the way it does contracting through the development of a new Vendor Performance Management framework.

As part of the developmental work associated with the framework, they are seeking feedback from industries on proposed pilot materials through a Request for Information posted on their website: <https://buyandsell.gc.ca/procurement-data/tender-notice/PW-21-00950744>

The goal of establishing and implementing a new Vendor Performance Management framework is to establish an objective, structured, and reliable way to evaluate the performance of vendors on federal government contracts. Ultimately, they aim to use performance information to supplement technical proposals and the proposed pricing to inform future contract award decisions.

The Vendor Performance Management framework is being implemented using a phased approach. The first Phase is the targeted testing of the Vendor Performance Management framework through a pilot version. The pilot version of the framework has been developed and will be tested through select contracts in five commodity areas: Apparel; Marine/Small Vessels; Construction; Fairness Monitoring; and Task Based Informatics Professional Services. In advance of launching these pilots in the summer of 2021, they are seeking your feedback on the following:

Surviving Long Term Sequelae of Electrical Shock Hazard Exposure

The electric shock hazard has been neglected. Journeyman Electricians have accepted been shocked as part of the job, a "right" of passage, a badge of honour. This has not been acceptable and Journeyman Electricians may not be aware of the long term sequela health effects of receiving multiple low voltage electrical shocks and how it may have impacted them. With respect to treatment there is only a single formal recognized treatment centre in Canada, the St Johns Rehab Centre. Electrical Injury Program. When a worker is exposed to the electric shock hazard there are two possible outcomes. A shock is received and the worker survives or they die. Electrical incidents statistics confirm that fatal electrical injuries from the shock hazard are occurring at an alarming rate, on average still once a day in North America. What is not published in electrical incident statistics reports is the number of electrical workers that may suffer from the long term effects of receiving multiple low voltage ($\leq 750V$) shocks. Agenda and Minutes from December 4, 2020 were approved. The new Mission and value statement were approved a study on the electrical industry in Canada prepared by Netco was shared with Board. Registration package for Convention 2021 was approved ([2021 Convention Registration Package](#)). Labour AGM will be held virtually on Tuesday, May 18th; PEC AGM will be held virtually on Wednesday, May 26th. Awards luncheon and Presidents Gala will be offered via zoom and features entertainment of interest to all our members. ***Proceeds from the virtual gala entertainment will be setup as a donation to support ECAA members who have struggled with Mental Health.**

Correspondence items included a letter to Minister Panda. Service Alberta is the Ministry taking the lead on prompt payment initiatives. Infrastructure and Transportation don't have to follow the legislation (letter to Minister Panda, Infrastructure asked for harmonization amongst Ministries to follow Prompt Payment legislation). Tentative enforcement date is July 1, 2021. Alberta Trade Contractors Coalition is putting a bid to be one of the adjudication authorities. Letter sent from President Brundage to Sustainable Energy and Agriculture Association of Alberta (SEAAA) supporting their application to the Sectoral Initiative Program with Employment and Social Development Canada for "*Rebuilding Communities Capacity through Agriculture, Electrical & Renewable Energy Programs*".

A letter was received from CECA stating that Ontario has dropped their membership in the national association. Letter sent to ECAO asking them to reconsider as Alberta feels there is a need for a national body representing the electrical industry in Canada. Request received from Safety Codes Council for a PEC to be included in the master's working group; as well as volunteers to participate in a stakeholder meeting regarding the master's program.

Legal Assist joined the meeting at 9:25 am making a presentation on how they can assist our membership with legal services. January financials were reviewed; BDO joined the meeting at 10:00 and walked Board through the 2020 year-end financials. List of outstanding memberships were reviewed. Request for Don Kuziw, Member Relations to make phone calls to contractors and associates on the list. Sheri will send exit email to PEC's.

The following members were approved in their respective categories: Associate – Axe Fire Protection (Edmonton); Robertson Electric Wholesale (Edmonton); Team Pawluk – Legal Shield Independent Associates (Calgary); Umbra Engineering (Edmonton). Chapter and Committee reports were presented. Thank you to all our members who continue to participate on the zoom Chapter meetings. Dave Hagen introduced Grant Wagar as his replacement on the Board. Welcome Grant!

Update to Board on NAIT's two-year electrical diploma recently approved by the Minister. PAC reviewed curriculum, similar to the electrical one. NAIT will begin taking students in September for the diploma program. Technical training will be completed in two years; apprenticeship program can be entered into following completion of diploma. Alternate education path to becoming a journeyperson electrician. Course outline review continues with a fall 2022 target. Red Seal occupational standards also being reviewed. AIT sent notices to 9500 apprentices suspending period exams and attendance requirements from January – July 2021.

It was noted that material prices are increasing due to shortage of product. Marketing campaign will focus on (1) on-line courses available; (2) PEC program. A social media challenge will roll out soon. Terry Barnett moved and Neil Moffatt seconded acceptance of this report. There is optimism in the travel industry that the out-of-country convention to Africa will proceed. 40-45 people have signed up.

ECAA has a new on-line training portal. The revised Ethics course turned out very well and is now live. A meeting was held with the course instructors last week. Code update training is being provided. ECAA is promoting Terry Becker's arc flash training. The PEC AGM will be held virtually on Wednesday, May 26, 2021 (prior to the golf tournament). The PM Elec is currently in a holding pattern.

ECAA 60th Anniversary is November, 2022. Board approved approaching Calgary Chapter to host as part of their Winter Gala. Rewritten ByLaws approved for circulation to Past Presidents and then Membership for comments and approval at the Annual General Meeting. Meeting adjourned at 12:05 pm.

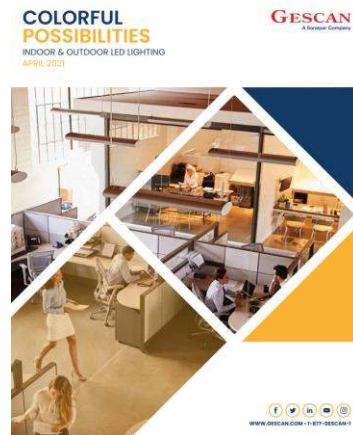
