Update Regarding Residential System Grounds from Epcor & City of Edmonton.

This update was rolled out jointly by **The City of Edmonton & EPCOR to the Canadian Home Builders Association (CHBA)**. *Details will also be included in the July Building Edmonton Newsletter issued by the City.*

Please see the following from Gerry Wiles, Chief Electrical Inspector, City of Edmonton

There has been a problem with system grounds, mostly ground plates and wire in new homes. Some of these problems have been the installation at the time of the build (not providing a good ground), others have been on zero lot line homes where the ground plates are exposed or ground wire cut during the dig for the next new home beside the existing home. This is a serious safety issue.

To fix the problem we will move to the following installation method.

- Starting August 1, 2021 all ground plates shall be installed inside the basement of a new home 600mm below finished grade (top of basement slab) and will be inspected as part of the service inspection.
- There will be an option to install 20 ft. of copper wire in the footing but this will require an inspection at the time of installation and there will be an additional inspection fee if done this way.
- Please see attached notice from EPCOR Distribution with additional details.

Effective immediately, there will be no requirement for the power and gas riser to maintain a minimum distance of 1.2m separation as outlined in the current Installation Guide for New Residential Utility Service 2020 located [here](#). Instead, the need for the builder to meet the requirements outlined by ATCO in the following diagram will be required. This pre-existing 1.0m requirement from the service regulator vent to a source of ignition (including vents/exhausts/water sources, etc.) ensures CSA B149 Gas Code and relevant Electrical Code are met. Should the builder not be able to maintain these minimum clearances, the builder may be subject to:

- failed final inspection by the City of Edmonton, or
- gas meters being locked off by ATCO

Kenya is Open to Visitors

We continue to communicate directly with Kenya, and they are now open for visitors with proof of a negative Covid-19 PCR-based test. Many countries in Africa have experienced past pandemics and therefore their safety protocols are very sophisticated and streamlined in comparison.

Deposits

We've extended our deposit deadline until August 2nd.

We've been pushing the deposit deadline out with suppliers but now lodges are beginning to sell out due to the pent-up demand. If deposits are required sooner, we will contact you with proper notification.

Cancellation and Medical Insurance

Manulife is offering cancellation insurance.

Flights

Jackie Abello in our office will be organizing group space for flights.

KLM has confirmed that they will resume their flight schedule from Edmonton and Calgary to Amsterdam.

Flight schedules are frequently changing to accommodate demand as travel begins to open.

All international airlines require that travelers test negative for Covid-19 within 72 hours of boarding a flight, in both directions. Vaccinated Canadian visitors to Kenya are welcome without restrictions but still require proof of testing negative for Covid-19 upon arrival.

Vaccinations for Kenya / Uganda

Yellow Fever Vaccination

All visitors to Kenya and Uganda are required to have proof of a Yellow Fever vaccination.

If you have not received your vaccination, please consult with your doctor or your local immunization clinic.

Please Note:

The risk of Yellow Fever is very low, Kenya has not experienced Yellow Fever since 1992, and it was only detected in a rural area.

Malaria is also a very low risk and Malaria pills can be purchased from your doctor or vaccination clinic.

Hepatitis A and B shots are always recommended for all travel to tropical or subtropical destinations.
