RE: Tech Associations Should be Eligible for Paycheck Protection Program

Dear Speaker Pelosi and Leaders McConnell, McCarthy and Schumer:

On behalf of the Technology Councils of North America (TECNA), we strongly urge Congress to act swiftly to allow trade and membership associations to access the Paycheck Protection Program (PPP) under the CARES Act. We believe this can be done in a technical correction bill or through Administrative rule-making.

TECNA is grateful to Congress and the Administration for current CARES Act provisions that allow 501(c)(6) organizations to access certain aid through an employee retention tax credit (Section 2301) and Economic Injury Disaster Loans (EIDL; Section 1110). But providing our members access to the PPP is critical.

TECNA member associations are active in 35 states and serve over 20,000 tech firms and hundreds of thousands of employees across the U.S. Technology councils are critical drivers of job creation and economic growth in states and regions throughout the U.S. Our members are the force behind supporting growth companies, entrepreneurs, start-ups, access to capital and establishing hubs for innovation. TECNA members offer a wide range of workforce development programs that provide key training and certifications to tech industry employees. Our members also have dynamic programs to develop the talent pipeline in elementary, secondary and higher education systems.


With nearly 12 million workers, tech employment accounts for nearly 8 percent of the nation's work force. The median tech occupation wage is over \$80,000, 92 percent higher than the median national wage for all occupations. Exports of U.S. tech industry products is estimated at \$340 billion, a critical indicator of economic strength. Overall, the tech sector has an estimated direct economic impact of \$1.8 trillion, or about 10 percent of the total U.S. economy, making it a critical industry. And as we navigate through this devastating pandemic, technology innovation will be a key part of the solution.

Now, more than ever, the tech industry is relying on our member associations for their survival. Our members have already incurred financial losses due to cancelled programs and events and anticipate further losses in revenues, as the tech industry addresses their own economically precarious circumstances.

We urge that you take immediate action to allow all 501(c)(6) organizations access to the Payment Protection Program.
