Pathways to a Low-Carbon Future

National Fuel Believes:

Essential to leverage use of existing gas transmission and delivery infrastructure

- Highly reliable and resilient
- Underground, storm-resistant and largely paid for by consumers
- Provides for multiple sources of energy and storage, and multiple delivery options for homes and businesses
- More affordable for consumers



National Fuel's "Pathway to a Low-Carbon Future"

Key CAC Advisory Panel and Working Group Recommendations

Support:

- Gas planning study to optimize coordination of new and existing technologies and infrastructure
- Advancing investment and RD&D into biofuels, hydrogen, CCS and long-duration storage
- Steps to lower near-term adoption costs of deep energy efficiency measures, and dual-fuel heating systems

Concerning Proposals:

- "Decommissioning" of gas delivery system
- "Electrify everything" policy
- Prescriptive bans for natural gas equipment replacements/installations
- Moratorium on new and repowered fossil-fueled generation facilities
- Economy-wide carbon fee (CCIA)



Need: Visibility on consumer cost impacts

Climate Action Council Scoping Plan

Draft scoping plan, due Jan. 1, 2022, will include 3 core scenarios:

- Strategic use of Low-Carbon Fuels
- Accelerated Transition Away from Fuel Combustion
- Beyond 85% Reduction in 2050 (a blend of elements from the other 2 scenarios)

Each scenario to incorporate: widespread energy efficiency, various levels of electrification and low-carbon fuel use in the buildings & industry, transportation, power and waste & agriculture sectors.



Navigating the New Federal Vaccine Mandate for Employers





President Biden's September 9, 2021 Announcement



President Biden's 9.9.21 Announcement

Requiring all employers with 100+ employees to ensure their workers are vaccinated or tested weekly

Requiring vaccinations for all federal workers and for millions of contractors that do business with the federal government

Requiring COVID-19 vaccinations for 17 million health care workers at Medicare and Medicaid participating hospitals and other health care settings

Calling on large entertainment venues to require proof of vaccination or testing for entry

Requiring employers to provide paid time off to get vaccinated
