The Wenatchee Valley Chamber Network groups meet twice per month in a networking environment to cultivate their business through leads and referrals while also creating a support network of fellow business professionals that they can lean on for advice, guidance and celebrate victories with.

The Wenatchee Valley Chamber Network Guidelines

- * *Wenatchee Valley Chamber Network* group members must be members of the Wenatchee Valley Chamber in good standing.
- * Participation is \$100 annually per person.
- * Chamber member businesses can have up to two employees (only 1 per group) from their business participate in the WVC Network.
- * More than three absences per quarter will constitute removal from the group.
- * Each member is responsible for bringing at least one new lead to each meeting.
- * Group members are responsible for their own meeting logistics and costs. The WVCC Conference room can be used for free subject to availability.
- * A minimum of 10 members is needed to create a new group. Groups will have a maximum of 20 members.
- * One participant per group industry category. If your category is filled, you apply to another group.

If all groups are filled for your category, you will be waitlisted.

- * The Wenatchee Valley Chamber will maintain a waiting list by group industry category.
- * A Chair person is elected by group members for a term of one year.
- * *Wenatchee Valley Chamber Network* Groups will not accept applications from individuals that are members of other leads/referral groups.
