LIVE CALCUTTA WITH 100 % PAYOUT!

- Starting bid is \$190.
- Combined stringer (3 trout & 2 redfish & 1 flounder). Payout is 3 places and will be 50%, 30%, and 19% of optional income. A 3 SPECIES SLAM, PREVAILS OVER A PARTIAL STRINGER, IN THE EVENT THAT NO BOAT WEIGHS IN A 3 SPECIES STRINGER, THAN WEIGHT PREVAILS.
- Trout must measure between 17" 23".
- Redfish must measure between 20" 28"
- Live Calcutta to be held Friday, August 19th at The Port O'Connor Community Center. A team representative from each team must be present for the Calcutta/Captains Meeting.

* Option: Buy half your own boat back from the person with the winning bid on your boat. You must buy half your boat back at the end or prior to the end of the Calcutta on Friday night. CBA is not affiliated with any buy backs of boats. It is YOUR responsibility to get with the buyer by deadline.

2022 TOURNAMENT RULES & REGISTRATION

- Tournament will take place from 6:00 AM to 3:30 PM. Each boat must launch in Port O'Connor, but may fish in any bay and /or surf.
- In the event of inclement weather, or cancellation for any reason, the tournament will be rescheduled. No refunds will be given for any reason.
- First cast is at 6:00 AM (Central time), Saturday, August 20st.
- Anglers must hold a valid Texas Fishing License.
- Only 1 watercraft / vessel per team.
- <u>All passengers in the boat must be entered in the</u> <u>tournament</u>, with a limit of four fishermen per boat and/or one (1) non-fishing hired guide.
- <u>All substitutions must be made at registration</u>. <u>No substitutions will be allowed after registration</u> <u>closes</u>.
- All fish must be caught by rod and reel by your team during tournament hours.

- No pooling of catches between boats.
- Weigh-in begins at Community Center at 2:00 PM and ends at 4:00 PM. Must have weigh in tag to weigh in.
- Anglers must check in & be in line by 4:00 PM to be eligible for weigh-in.
- No pale, gilled, or mutilated fish will be weighed. Tournament officials will make this determination. (A trimmed tail is a mutilated fish.)
- No re-weighs.
- Official measuring board used will be the "Check-It Stick"
- All fish must be within the legal limits permitted by law. No redfish over 28" will be weighed in. No trout over 23" will be weighed in. No substitutions will be allowed for disqualified fish. No bull reds. ILLEGAL FISH IN ANY CATEGORY WILL BE CAUSE FOR IMMEDIATE DISQUALIFICATION IN THE TOUR-NAMENT. The tournament will be following the latest Parks & Wildlife Regulations.

- Length prevails in case of a tie on weight for trout, redfish, flounder, and other big fish. If there is still a tie, first weighed in will be declared the winner. In case of a tie for the Calcutta or spot pot, the first weighed in will be declared the winner.
- <u>NO FISH WEIGHED IN FOR THE POTS, CAN BE</u> <u>USED IN THE CALCUTTA.</u> Each boat may place only once per category.
- All decisions of Weighmaster/Tournament Officials are final.
- Safety, sportsmanship, and conservation are expected from all participants.
- Violations of any federal, state or local laws, or tournament rules & regulations will result in disqualification of the entire team from the fishing tournament (this includes the weigh-in of any illegal fish in all categories).
- Winners will be subject to a polygraph test. ALL team members of each winning team must be present for the "random" polygraph drawing, determining which member will take the polygraph.
