The second portion of our Virtual 4R Field Day will introduce viewers to the Minnesota 4R Nutrient Stewardship Certification Program. This program, which will be administered by the Minnesota Crop Production Retailers, was developed with input from fertilizer manufacturers and retailers, environmental organizations, state agencies, farm organizations and University of Minnesota researchers. Launched this fall, the program will help insure that retailers and their farmer customers are applying crop nutrients at proper rates and following best available science to optimize productivity, strengthen relationships between nutrient service providers and their customers, preserve natural ecosystems by growing more on less land, supporting state and nation-wide efforts to reduce nutrient runoff, and help safeguard drinking water supplies.
