#### Medical Examiner's Certification Integration Delayed Again

DOT has <u>delayed</u> the compliance date for several provisions of the 2015 Medical Examiner's Certification Integration final rule again. The regulation's compliance date is extended from June 22, 2021 to June 23, 2025. This final rule will provide DOT time to complete certain information technology system development tasks for its National Registry of Certified Medical Examiners and to provide the state driver's licensing agencies sufficient time to make the necessary IT programming changes when the new National Registry system is completed and available.

The existing process of submitting medical certifications to the state remains intact for four more years. Drivers need to continue to provide state driver's licensing agencies a copy of their Medical Examiner's Certificate and carry proof of the medical certification for 15 days. The motor carrier needs to continue verifying that drivers were certified by a certified Medical Examiner listed on the National Registry and obtain a Motor Vehicle Record within 15 days of the exam that shows the most recent medical exam. #### DOT Cautions Drivers About CBD Products

More than 75,000 drug and alcohol program violations have been reported to DOT through the Clearinghouse since January 6, 2020. Positive drug tests account for over 80% of these violations, and marijuana has been detected in over half of all drug tests that have been filed in the Clearinghouse. It is important for all employees who perform safetysensitive functions, including CDL drivers, to know the labeling of many CBD products may be misleading because the products could contain higher levels of tetrahydrocannabinol (THC) than what's stated on the product label.

DOT's Drug and Alcohol Testing Regulation does not authorize the use of Schedule I drugs, including marijuana, for any reason. CBD use is not a legitimate medical explanation for a laboratory-confirmed marijuana positive result. Therefore, Medical Review Officers will verify a drug test confirmed at the appropriate cutoffs as positive, even if an employee claims they only used a CBD product. Since the use of CBD products could lead to a positive drug test result, DOTregulated safety-sensitive employees should exercise extreme caution when considering using CBD products. (Asmark Institute)

#### WOTUS To Be Redefined Again

EPA and Department of the Army have announced their intent to revise the definition of "waters of the United States" (WOTUS). Upon review of the Navigable Waters Protection Rule, the agencies have determined that the rule is significantly reducing clean water protections. The lack of protections is particularly significant in arid states, like New Mexico and Arizona, where nearly every one of over 1,500 streams assessed has been found to be non-jurisdictional.

The agencies are also aware of 333 projects that would have required Section 404 permitting prior to the Navigable Waters Protection Rule, but no longer do. #### COVID Waiver Again Permits CDL Extensions

DOT has extended the <u>waiver</u> for expiring Commercial Driver's Licenses (CDLs) and permits, as well as Non-CDL licenses for commercial motor vehicle (CMV) drivers, until November 30, 2021 in response to the COVID-19 public health emergency.

While many States have now reopened their State Driver Licensing Agencies (SDLA), the delta variant has impacted the pace of return to normal customer service levels in some States. As a result, some CDL holders may be unable to renew their CDLs or provide medical certificates to their SDLA. DOT intends to review the status of this waiver as of October 1, 2021 and may act to terminate the waiver sooner if conditions warrant.

Drivers claiming relief under this waiver must continue to carry a paper copy of their expired medical certificate. **Please Note:** Drivers are strongly encouraged to obtain their renewed licenses and medical certificates as soon as possible. (Asmark Institute)

#### EPA Sunsets Temporary Respirator Guidance

In June 2020, EPA issued temporary guidance that offered flexibility during the COVID-19 public health emergency to agricultural employers and pesticide handlers regarding respiratory protection requirements related to pesticide uses covered by the Agricultural Worker Protection Standard (WPS). Due to improvements in access to NIOSH-approved respirators, fit testing supplies and related services, EPA is terminating the June 2020 guidance and its May 2021 amendment, effective August 19, 2021.

The decision to end these flexibilities is in alignment with federal agency

guidance issued by the Centers for Disease Control and Prevention, the Food and Drug Administration, and the Occupational Safety and Health Administration that entities should no longer use crisis capacity strategies for respirators and should promptly resume conventional practices. #### **USPS Rates Go Up**

The Postal Service has scheduled a second postage rate increase for mailing services that were implemented on Sunday, August 29, 2021. This is the second USPS postage rate increase of 2021, with the first rate increase going into effect on January 24, 2021. There are a number of products and services affected by the rate increase but the most commonly used services in our industry are listed below:

- First-Class Mail Forever stamp will increase from \$0.55 to \$0.58.
- First-Class Mail Metered rate will increase from \$0.51 to \$0.53 for a 1 oz. envelope. The rate for each additional ounce will remain the same at \$0.20.
- First Class Mail Flat Envelope rate will increase from \$1.00 to \$1.16 for a 1 oz. envelope.
- First Class Mail Postcard rate will increase from \$0.36 to \$0.40.
- Priority Mail Regular Flat-Rate Envelope will remain the same at \$7.95.

#### Are Your Federal Drug Testing Forms Current?

On August 17, 2020, DOT released a revised Federal Drug Testing Custody and Control Form (CCF). One of the updates in the revised CCF is the addition of "CDL State and No." to the line that captures donor identification information (Step 1-C). Including a driver's commercial driver's license (CDL) number and State of issuance for all DOT-regulated tests assists medical review officers (MROs) in reporting violations in the Drug and Alcohol Clearinghouse.

As of August 30, 2021, DOT-regulated employers must use the revised CCF. If you use a drug testing company, they will be able to provide this form upon request. (*Asmark Institute*)

#### EPA Bans Chlorpyrifos Use on Food

EPA announced it will stop the use of the pesticide chlorpyrifos on all food. EPA is revoking all "tolerances" for chlorpyrifos and will issue a Notice of Intent to Cancel registered food uses of the pesticide. This follows an order in April by the Ninth Circuit Court of Appeals that directed EPA to halt the agricultural use of chlorpyrifos unless it could demonstrate its safety. This new rule will take effect in 6 months.

Chlorpyrifos has been registered for use in the United States since 1965. The agency will proceed with registration review for the remaining non-food uses of chlorpyrifos. (*Asmark Institute*)

#### Increased Safety Measures for Paraquat

As part of the registration review for the pesticide paraquat dichloride, EPA is finalizing new, stronger safety measures to reduce exposure. These measures include:

- Limiting aerial applications and requiring residential buffers.
- Prohibiting pressurized handgun and backpack sprayer applications.
- Requiring enclosed cabs or respirators for groundboom applications.
- Increasing the Restricted Entry Interval (REI) for several crops.

In addition, EPA is updating the Restricted Use Pesticide statement on paraquat labels to allow truck drivers who are not certified applicators to transport paraquat when certain conditions are met. (Asmark Institute)

## MCPR Participates in Soil Stewardship & Nutrient Management Field Day Highlighting 4R's

On September 1, MCPR participated in a Soil Stewardship & Nutrient Management Field Day held near Albany, MN that was organized by the Stearns County Soil & Water Conservation District in partnership with the Minnesota Ag Water Resource Center, 4R Alliance, the Nature Conservancy, University of Minnesota Extension, and MCPR member Centra Sota Cooperative.

This full-day event included presentations on soil health, 4Rs of nutrient and manure management, ag data stewardship, a farmer panel, and equipment demonstrations in the field. Key themes included how soil health and nutrient management plays a large role in making sure farmers can achieve sustainability and profitability. In addition, several local lawmakers also participated including Minnesota House Agriculture Finance & Policy Committee Ranking Member Paul Anderson (R – Starbuck) and Senator Jeff Howe (R – Rockville).

## Minnesota Nutrient Stewardship Council Approves Certification of Nutrien Ag Solutions Facility in Big Lake

Last month, the Minnesota Nutrient Stewardship Council (MNSC) unanimously approved certification of the Big Lake Nutrien Ag Solutions facility in Big Lake. The Minnesota **Crop Production Retailers and MNSC** would like to congratulate Nutrien Ag Solutions for their commitment in working with the Minnesota 4R team to accomplish this achievement. The Nutrien Ag Solutions Big Lake facility is now the very first Minnesota ag retailer to have reached certification through the 4R program. The certification comes on the heels of MCPR staff observing the first ever audit conducted in Minnesota on behalf of the MNSC. As the administrator of the state program, MCPR looks forward to seeing more ag retail facilities participating in the

program with the goal of also being certified by the council.

For background on the 4R Nutrient Stewardship Certification Program, it is a proactive, responsible commitment aimed at the long-term improvement of water quality throughout the state. The program encourages agricultural retailers, service providers, and other certified professionals to adopt proven best practices through the 4Rs, which refers to using the Right Source of Nutrients at the Right Rate and Right Time in the Right Place. This approach provides a science-based framework for plant nutrition management and sustained crop production, while considering specific individual farms' needs. The partnership between the 4R Program and MCPR was solidified in 2020 when the program was officially launched in Minnesota. Several other states and Canadian provinces have similar programs, with the first one being launched in March 2014 to address water quality concerns in Lake Erie. Originating in the Western Lake Erie Basin in Indiana, Michigan and Ohio, the 4R Program expanded to the full state of Ohio in 2017, and internationally in 2019.
