# Minnesota's Ag Retail Community Comes Together for the 2021 CPM Short Course & MCPR Trade Show

Approximately 800 ag retailers, certified crop advisors, educators, exhibitors, and sponsors descended on Minneapolis in December for the 2021 Crop Pest Management Short Course and Minnesota Crop Production Retailers Trade Show. After the event was cancelled in 2020 due to the pandemic, there was an energy in the air all week as many attendees connected once again face-to-face with their colleagues for what is the premier event for Minnesota's ag retail sector.

A new venue also received positive reviews from trade show exhibitors, as well as those who attended the short course to obtain their educational credits. The theme for the show was "Let's Get Real" and MCPR Board Chairman Rick Walker echoed that sentiment as he welcomed attendees back to the Twin Cities after a challenging year and a half. He mentioned how the ag retail industry was very thankful to be back together in-person and how folks were able to partake in educational sessions, as well as social functions, with their peers from all over the Upper Midwest.

Hosted by MCPR and the University of Minnesota Extension, participants once again experienced a timely educational programming and trade show experience over the course of the three-day event. The MCPR Board of Directors and staff can't thank everyone enough – especially our generous exhibitors and sponsors – for their support of this timely and critical gathering for the ag retail sector.

Other highlights of the short course and trade show included several

thought-provoking sessions during the MCPR Plenary Session on Tuesday afternoon. Among them were presentations from the former Chairman of the U.S. House of Agriculture Committee, a discussion on the mercurial nature of fertilizer prices and supply chain issues in the current global economy, as well as an informative panel discussion on the current challenge the ag retail industry faces to hire and retain talent in the ever-changing workforce.


# Leading Industry Analyst Explains Why Fertilizer Prices are Heading Towards Record Highs

Josh Linville from the StoneX Group brought passion and energy to his remarks on December 7 as to why the fertilizer industry is swarmed with Black Swan events. From the impacts of Hurricane Ida to political and climate issues entangled in a cobweb of production slowdowns in Europe and China, Linville explained in detail how these events continue to stack up. His unique perspective and years of experience on the fertilizer marketplace helped explain what is happening in this arena and why. He also went into detail on why global fertilizer prices have gone from near historic lows to historic highs in a twelve-to-sixteen-month period, as well as what to expect going forward.

## **Panel Discussion Focuses on Search for Ag Workforce Talent**

A big problem for ag retailers, manufacturers, and distributors in the crop input industry is the struggle to find talent and create a pool of potential hires. Ag retailers need strong leadership and top employment recruits to succeed. But many are located in rural areas or smaller communities where the population is limited, and unemployment rates are so low that it's hard to find interested talent that fits the bill. This is why being proactive when recruiting an ag workforce is so important.

Keith Olander and Judy Barka from AgCentric were joined by MCPR Board Directors Dale Johnson from AgPartners and Arnie Sinclair from Heartland Ag Systems as they explained how they have dealt with workforce retention at their respective companies over the years. Abby Reiners from Heartland Ag Systems also shared her experience about how she started out as intern at the company that eventually led to a full-time position.

Outgoing board chairman, Tim McArdle, retired COO of Brandt, and vice chairman, Dave Ito, Vice President of Regulatory Affairs for Grow West, who each served six years on the ResponsibleAg board, were honored during the closing session at the ARA Conference.

ResponsibleAg is an industry initiative launched in 2014 to help retail facilities comply with federal environmental, health, safety and security rules for safe handling and storage of fertilizer and agrichemical products. Primary objectives of the initiative are to ensure the safety of employees and local communities served by agricultural retailers, distributors and fertilizer manufacturers. (*Asmark Institute*)

#### Annual Inspection of Rear Impact Guards Required

DOT has issued a final rule that requires motor carriers to inspect their vehicles' rear impact guards as part of the annual inspection. While the regulation requiring rear impact guards has existed since 1952, they have not been included on the list of components in Appendix G that must be inspected during the annual Commercial Motor Vehicle inspection. This means that a vehicle could pass an annual inspection with a missing or damaged rear impact guard.

49 CFR 393.86(a) currently requires most trailers and semitrailers manufactured on or after January 26, 1998, to be equipped with rear impact guards. This final rule does not require installation or maintenance of rear impact guards beyond the current requirements in section 393.86. The final rule is effective December 9, 2021.

# AGCO Names 2021 Operator of the Year

The award recognizes professional applicators for skills, dedication and service to their local communities.

AGCO has supported and recognized the industry's top professionals through the AGCO Operator of the Year Award program since 2005. The Asmark Institute collaborated with AGCO to offer the Applicator Training Center in Bloomington, IL, a training program dedicated to educating and developing both new and experienced custom applicators of crop protection products and plant nutrients. #### OSHA ETS on COVID-19 Vaccination and Testing Reinstated

The 6th US Circuit Court of Appeals has lifted the stay of OSHA's Emergency Temporary Standard (ETS). OSHA issued the ETS to protect unvaccinated employees of large employers (100 or more employees) from the risk of contracting COVID-19 by strongly encouraging vaccination. Covered employers must develop, implement and enforce a mandatory COVID-19 vaccination policy, unless they adopt a policy requiring employees to choose to either be vaccinated or undergo

regular COVID-19 testing and wear a face covering at work.

The ETS also requires employers to do the following:

- Provide paid time to workers to get vaccinated and to allow for paid leave to recover from any side effects.
- Determine the vaccination status of each employee, obtain acceptable proof of vaccination status from vaccinated employees and maintain records and a roster of each employee's vaccination status.
- Require employees to provide prompt notice when they test positive for COVID-19 or receive a COVID-19 diagnosis. Employers must then remove the employee from the workplace, regardless of vaccination status; employers must not allow them to return to work until they meet required criteria.
- Ensure each worker who is not fully vaccinated is tested for COVID-19 at least weekly (if the worker is in the workplace at least once a week) or within 7 days before returning to work (if the worker is away from the workplace for a week or longer).

•

Ensure that, in most circumstances, each employee who has not been fully vaccinated wears a face covering when indoors or when occupying a vehicle with another person for work purposes.

The emergency temporary standard does not require employers to pay for testing. To account for any uncertainty created by the stay, OSHA is exercising enforcement discretion with respect to the compliance dates of the ETS. To provide employers with sufficient time to come into compliance, OSHA will not issue citations for noncompliance with any requirements of the ETS before January 10 and will not issue citations for noncompliance with the standard's testing requirements before February 9, so long as an employer is exercising reasonable, good faith efforts to come into compliance with the standard.

OSHA is seeking <u>comments</u> on all aspects of this ETS and whether the agency should adopt it as a final standard, through January 19, 2022. Several groups have already filed a petition with the US Supreme Court for an emergency stay of the rule. (*Asmark Institute*)

#### IRS Increases Standard Mileage Rates for 2022

The IRS has issued the 2022 optional standard mileage rates used to calculate the deductible costs of operating an automobile for business, charitable, medical or moving purposes.

Beginning January 1, 2022, the standard mileage rates for the use of a car (also vans, pickups or panel trucks) changed to:

- 58.5 cents per mile driven for business use, up 2.5 cents from the rate for 2021,
- 18 cents per mile driven for medical, or moving purposes for qualified active-duty members of the Armed Forces, up 2 cents from the rate for 2021 and
- 14 cents per mile driven in service of charitable organizations; the rate is set by statute and remains unchanged from 2021.

The standard mileage rate for business is based on an annual study of the fixed and variable costs of operating an automobile. The rate for medical and moving purposes is based on the variable costs. Taxpayers always have the option of calculating the actual costs of using their vehicle rather than using the standard mileage rates. (Asmark Institute)
