2022 Annual Awards Banquet Nomination Criteria

In keeping with the important role that business plays in the American Free Enterprise System, each year the Cedar Park Chamber of Commerce proudly recognizes the finest our area has to offer. This recognition will take place during our Awards Luncheon. We will recognize the following categories:

- **Small Business of the Year (1 -50 employees)**
- **Large Business of the Year (51+ employees)**
- **Non-Profit of the Year (501c3)**
- **New Business of the Year- Opened after January 1, 2020.**

The public is encouraged to submit nominations. Any business you respect and admire would be a good candidate. Think of your friends, neighbors, clients, suppliers, or competitors. Do any of them exhibit exemplary spirit, skill, productivity, customer service or have they made important contributions to the community?

Small and Large Business Category: The business shall be a privately-held business (no not-for-profits). The business shall have been a member in good standing of the Cedar Park Chamber of Commerce for a minimum of three (3) years- with the exception of the New Business of the Year category.

Non Profit Category: The non-profit should be a 501 (c)(3). The non-profit shall have been a member in good standing of the Cedar Park Chamber of Commerce for a minimum of three (3) years.

The following will be considered in the selection process:

- Has the business practiced exemplary business conduct & responded positively to adversity in business?
- Demonstrated outstanding customer service
- Evidence of contributions to aid in community projects.
- Strong business or management philosophy.
- Increase in sales and/or unit volume.
- Initiative in new job development and equal opportunity employment

Finalists may be interviewed by the Cedar Park Chamber of Commerce. The finalists will be announced prior to awards banquet. The awards will be presented at the Awards Banquet on Friday, February 25, 2022. Business Owners are welcome and encouraged to self-nominate. Officers of the Cedar Park Chamber of Commerce Board of Directors are ineligible to win the Small or Large Business of the Year awards. Previous winners are not eligible to win again for at least 3 years.
