
BLOCK PARTY SPONSORS, VOLUNTEERS NEEDED

YOUR VOICE in GOV'T



Minnesota Chamber reports businesses and employers can expect higher costs with proposed bills at the legislature:

- \$1 billion annual payroll tax on employers to pay for the 24-week paid leave mandate.
- Increased costs and time to comply with up to **80 hours** of fully paid sick and safe time paid leave.
- New proposed top capital gains rate of 13.85% would put Minnesota at the highest rate in the country.
- **Motor vehicle tab increase** from the governor by increasing the first year to 160% of the manufacturer's suggested retail price.
- **Ten new health insurance mandate** proposals in addition to the roughly 60 that are already in state statute. This list is already the second-longest in the country.
- **Utility customers would see increased costs** to pay for proposals such as EV infrastructure and rebates for electric cars, boats and planes and Electric school buses.

Chamber Mid-Session Day at the Capitol is Thursday, April 13th . MPR News reports that the MN Legislative Salary Panel has approved legislators receiving 7.25% higher wages starting this summer, its first increase since 2021. Read about it here!

Governor Walz's revised budget released a couple weeks ago is 25% MORE than the current two—year budget. Read Duluth News Tribune's article here!

Options Inc's March Newsletter encourages supporters to contact legislators to approve Senate File 1015, known as the Best Life Alliance bill, which was heard in committee a couple weeks ago. Additional investments are needed in the Disability Waiver Rate System (DWRS). The bill addresses the shortage of staff in disability services and proposes adjustments to the state-set reimbursement rates that determine staff wages, which currently are disproportionately similar to those of our local fast-food wages. This bill will help restore community employment for persons with disabilities with staff oversight.

American Experiment reports that Shark Tank's Kevin O'Leary, aka Mr. Wonderful, and his team have partnered with North Dakota to invest \$45 million into early-stage companies. He says he isn't investing in MN or neighboring Moorhead because of MN's business policies. Read more about it here!

MARCH'S COMMUNITY FAIR HAD RECORD ATTENDANCE!

The 2023 Big Lake Community Fair's attendance of 1274 people was a 37% increase over last year and a record attendance since 2017 when 1234 area citizens attended.

Big Lake High School Robotics students demonstrated their latest robot. Big Lake Lions provided 40



BIG LAKE GRADUATION RATES INCREASED IN 2021! Big



The Minnesota Department of Education has released the class of 2021's graduation rate data. The statewide graduation rate fell to 83.3%, which is a 0.5% decrease compared to the four-year graduation rate of 2020. At Big Lake Schools, the 2021 graduation rate increased to 95.3% from 90.3% in 2020.

"Our district has made tremendous progress supporting and improving education services for all students," says Superintendent Tim Truebenbach. "The hard work and dedication of our staff and students throughout the pandemic shows with the exceptional improvements in our graduation data."
