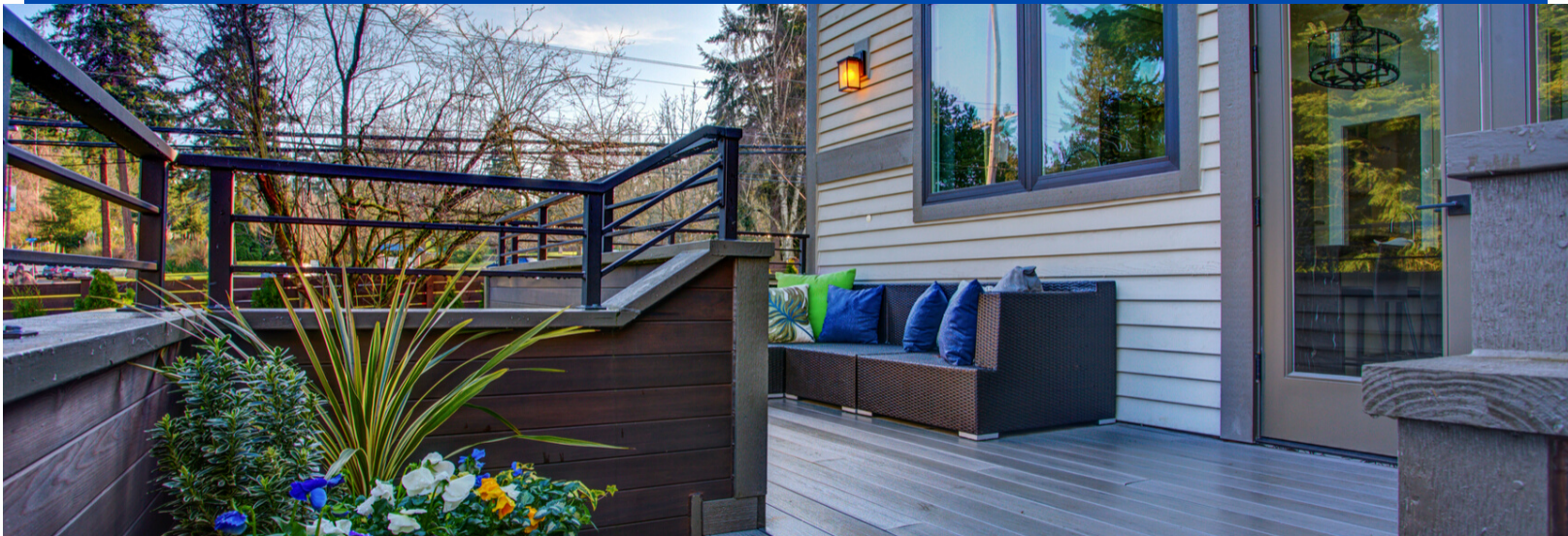

Update: City of Grand Forks

The Engineering Development Division has been monitoring frost conditions and has determined that pouring of concrete within the City right-of-way can begin on Monday May 4th, 2020.

IRS Extends Filing Deadline

The IRS has significantly broadened its tax return filing and payment relief in response to COVID-19. According to Notice 2020-23, nearly all taxpayers with a filing or payment deadline falling on or after April 1, 2020, and before July 15, 2020, will now have until July 15, 2020 to file returns and make payments without penalties or interest.

The expanded relief applies to individuals, partnerships, corporations, estates, and other non-corporate tax filers.
