 nomination. Please include their roles and activities within those roles, as well as any
 achievements throughout their banking career.
- We strongly encourage at least one additional letter of recommendation from a community or civic organization with your nomination letter.
- We always encourage you to resubmit nominations for prior candidates who were not chosen.

Since 1994, NH Bankers has honored an individual each year chosen by a panel of leading public officials. If your nominee did not receive the award in the past, we encourage you to submit your nomination again this year. You will be notified once a decision has been made by the Community Banker of the Year Review Panel.

This prestigious award will be presented during the banquet at the Annual Conference being held September 15-17, 2023 at Le Chateau Frontenac, Quebec City, Canada in partnership with the Vermont Bankers Association, Inc.

Along with a press release announcing the award winner, the recipient will also be displayed prominently within NH Bankers office for the following year.
