President Tim Smith - His recommendation is to pull the plug on McAllen and do it fairly quickly. Tim, can you enlightens anymore?

Tim Rutland – Well, I tell you the conversion that I have had are kind of the same, in terms of people that I have been visiting with lately, lay have all said the same thing. The have expressed real concerns going and basically said, they won't go. Because of the concerns that they have down there. In terms of logistics, part our decisions and part of your decisions is going to have to be the potential of penalties or possible penalties for pulling the flag on this. Of course we haven't had any discussion with anybody down there or any of the officials down there, or with the hotels any thing like that. Its something we will have to keep in mind. No positive feedback. There's a lot of concern out there, no doubt.

Hope that McAllen understands we are not abandon you for ever but right now is not the best time for them.

Secretary Brent Allen – I see the point, me personally you have that you have SWAT Teams down there, with that many problems, me I'm kinda like Mr. Boggs I don't believe I would like to be down there if they are having that many problems along that issue, I sure we can find somewhere to go. Hopefully, maybe somewhere.

 1^{st} Vice President Richard Van Winkle – You know I love the valley, I love going down there but I don't think I would not feel very safe for my wife or my grandkids to by themselves. I think it would be best if we move it.

2nd Vice President Chuck Richardson - I agree with Richard, I think of our families safety is of most important. Maybe we try to find some other place.

Chaplin Ben Kennedy – I talk to a friend of mind vada valley with the same situation, blatantly cutting barb wire fences, walk across like they own the place. Going into towns treating it like they own it, if you leave your car unlock it will be gone. I do not want to go to that at this time.
