 - The Certification Board has validated HM A&O and are conducting on-line testing. Multiple tests scheduled utilizing the online platform and it is working great. Currently SFFMA staff are proctoring test utilizing their computers. The goal is to transition to testing centers.
 - Draft of the Industrial FF program, awaiting final approval. The draft has been reviewed, sent to Keith Russell and changes/recommendations have been made. Tim's recommendation is for the TIESB adhoc committee review the document and see if changes need to be made so the document can be presented to the board for approval.
 - Underway with the development of a new data management system for the Organization (replacement for GrowthZone). A new website and user interface will be built. This is a modular concept and can be rolled out separately to testing. Target date for product unveiling is June '22.
 - '22 SFFMA conference will be in Beaumont (June 24-29, 2022). The format will be a traditional f-t-f delivery with trade show, presentations and an Industrial track (call for presenters) in place. MCM Elegante (host hotel and site for training tracks) and Ford Center for events.
