- License Plate Holders (K Creamer) No action, Kevin will review and follow-up with TxDOT
- David Atkinson has two members in MAMB who are interested. Ronnie Williams is also soliciting interest in the Corpus Christi area. Increased interest in TIESB Board membership.
- Procedural documents (R Williams) In progress
