Dates notated in **Red** are items to be completed by the NICA Member and Dates notated in **Green** are items to be completed by the Hummel Group. ### STARTING MAY 1<sup>ST</sup>

Provide Business Group information to a Hummel Group Contact (see form below):

### MAY 1<sup>ST</sup>- MAY 22<sup>ND</sup>

A member of the Hummel Group will send a medical health link for eligible employees to complete.

### MAY 25<sup>TH</sup>- JUNE 12<sup>TH</sup>

Once all employees have completed the link, underwriting will evaluate the group.

### JUNE 15<sup>TH</sup>- JULY 10<sup>TH</sup>

A member of the Hummel Group will provide a proposal and presentation of health benefits to your business.

### JULY 13<sup>TH</sup>- AUGUST 15<sup>TH</sup>

NICA Member will decide at this time if they would like to move forward with one or more plans. A member of the Hummel Group will then start the implementation process and send a welcome letter.
