

ISLANDERS FOR FERRY ACTION: ENGAGE FOR CHANGE!

We cannot wait years for reliable ferry service! Join your fellow islanders and use your voice to help Vashon. Advocate for more reliability and expanded ferry and water taxi service. Call or email your elected leadership and agency leaders (information on reverse) and support our Islanders for Ferry action core agenda:

- 1. Schedule adjustments on the Triangle Route:** we cannot wait years for reliable service. We request funding for WSF to study and adjust the current two boat schedule to make service reliable.
- 2. Prioritize ferry-dependent communities:** we ask that WSF prioritize ferry-dependent Vashon, including assignment of an Olympic class boat during the summer high season, until reliable three-boat service returns.
- 3. State subsidies for expanded water taxi service:** expanding water taxi service on weekdays, evenings, and weekends will help reduce car traffic and help passengers plan alternative transit during service disruptions.
- 4. Expedited ticketing program implementation:** we encourage WSF to accelerate the integration of systems like 'Good to Go' with 'Waves to Go' for a more efficient ticketing process across the network.
- 5. Designate money within WSF specifically for on-call crew for ferry-dependent communities:** this will help ensure that service disruptions are minimized and that our communities remain safely accessible.
