

**SUBJECT** : MnDOT CE ORD BETA Workspace for download/review

Hello MnDOT Consultant,

There is a newly updated MnDOT ORD “beta” workspace for your review. It is a ZIPPED file that contains the MnDOT ORD resources. There are two informational documents that cover the known issues that MnDOT has found and/or reported to Bentley.

- **Minnesota DOT ORD Migration Status.pdf** : covers items reported to Bentley
- **MnDOT Workspace Bentley Connect.docx** : a rough and evolving description of the contents of the MnDOT workspace. It includes notes about items we are working on or seeking to further expand. There may be items that have been addressed but remain listed as needed. In short - there is still clean up underway.
- **There is no documentation on how to configure or deploy these resources.**

Please note:

- The workspace is not considered production ready.
- Limited documentation.
- MnDOT continues to work on the components of the workspace to reach a production ready status.
- MnDOT is now running its workspace entirely inside of ProjectWise. This zip file was built from a Windows copy. You may need to adapt these resources into your local ORD system and configuration
- Tabulations/Quantities are being handled by Item Types and ORD Reporting

#### **DOWNLOAD INFORMATION:**

Its recommended that consultant engineers pass this information to their CADD Standards Manager or other individual responsible for configuring or testing new CADD resources.

- This may automatically start download – and you Select Save As
- It should download the file as **MnDOT-CE-ORD-BETA-WorkspaceExport2022-12-20.zip**
- File size is 91.640 MB (zipped)

If that Direct Link doesn't work (same site)

- Go to the Content Search page : [MnDOT eDOCS Public Web - Content Search \(state.mn.us\)](#)
- **Use the Content Search Option**
  - Key in either
    - the Doc # : **27188071**
    - the file name without the extension : **MnDOT-CE-ORD-BETA-WorkspaceExport2022-12-20**
- Then Search . It may take up to 30 seconds to return the result.
- Click on the Doc Name – to select the file and your browser should ask to either Open or Save As.
  - Please choose Save As and unzip after download.

#### **GENERAL NOTES :**

**ORD version adoption:** MnDOT is adopting ORD CE version 2022 R1 - but we anticipate migrating to a newer version ASAP in CY 2023.

**ORD Agency deployment:** MnDOT is planning to begin internal migration in February 2023 and will take 8-10 months to complete. Staff may keep PowerGEOPAK as dual load if necessary to complete projects but removal of PowerGEOPAK is an IT Priority. Bentley will delivery instructor led online training under contract to MnDOT staff only.

**ORD as Agency standard/required deliverable:** MnDOT has **not defined** ORD as production ready. MnDOT Project Managers may incorporate a requirement in consultant contracts to migrate to ORD for work that occurs after MnDOT has declared its ORD workspace as “production ready”.
