Must be a current Chamber Investor:

- involved in community service and activities that enhance the quality of life of the area
- employ more than 20 full-time employees

Small Business of the Year Award

Must be a current Chamber Investor:

- having made a significant and exceptional contribution to the local or regional economy
- employ fewer than 20 full-time employees

Honorary Lifetime Member Award

Must be an individual:

- who is retired or semi-retired
- active or financially supportive of the Chamber for years of combined service as an individual or through their affiliated company.

Not required to be a Chamber Investor

Farm Family of the Year

Recognizes outstanding contributions to Dunn County's agricultural industries and their communities. The award honors families who are committed to profitable production of quality products in a competitive business environment.

Not required to be a Chamber Investor

Good Neighbor Award

Recognizes a person in the Menomonie area for his/her extraordinary personal service to their community. The nature of the service provided contributions to the quality of life of individuals or groups in the greater Menomonie Area.

Not required to be a Chamber Investor

Distinguished Citizen

Recognizes a person that has provided extended period of continuing service and community involvement, added distinction to the area, provided service above individual or professional goals.

Not required to be a Chamber Investor

Non-Profit of the Year

Must be a current Chamber Investor:

- having made a significant and exceptional contributions to the local community.
- must positively impact our local community, making our county a better place to live
- must be established organization for 5 or more years.
