## Map to the Kenny Dixon Sport Complex in Bushnell

From Wildwood take Highway 301 south to Bushnell. After crossing the train tracks in Bushnell keep going straight onto W Noble Ave. Keep going straight past Purcell Funeral Home on the right, the Methodist Church on the left, straight to the 4-way stop at West Street. Go straight, cross Battlefield <sup>A</sup> oad and you should see the sports complex on your right; continue straight to the picnic area.
