**Directions to Catfish Johnny's**—Catfish Johnny's is located on the northwest end of Lake Panasoffkee on SR 470. Coming from Wildwood, you can take 301 to Sumterville and turn right at the second light onto SR 470 or you can take Interstate 75 to the Lake Panasoffkee exit and go west (right). The restaurant is on the left side of the road about 3.3 miles from the
