

A CALL FOR FREA/FREF NOMINATIONS – October 2023

Deadline: December 15

We are currently seeking nominations for the 2024 election – Job Descriptions are available in the FREA Bylaws and Standing rules, and FREF Bylaws. Both are available on the FREA website or by contacting the FREA Office.

Nominations are being sought for the position of FREA President-Elect – One 2-year term to then serve as FREA President for one 2-year term.

Nominations are being sought for the Trustees and District Directors.

- District Directors may serve two, two-year terms (4 years) and **must be nominated each term.**
- Trustees may serve three, three year-terms (9 years) and **must be nominated each term.**

Districts that are open for nomination for a new director/trustee, or with directors/trustees who may be nominated for a second or third (Trustees only) term, are:

District Directors:

District: 1 – Nominee needed
District: 2 – Nominee needed
District: 4 – Nominee needed
District: 5 – Nominee needed
District: 7 – Nominee needed

Trustees:

District 6: – Nominee needed
District 7: – Nominee needed

Any member within the districts above may be considered for the District Director/Trustee. Nominees for these positions must be members in good standing.

Nominations documents:

- A letter of nomination. **Self-nominations are not accepted.**
- An acceptance statement from the nominee indicating a willingness to be considered and to serve, if elected.
- If the nominee is NOT already serving in the position, the nomination documentation shall also include a biographical sketch, and a photograph.

- After the December 15 deadline, should a second Call for Nominations be necessary, that Call for Nominations shall only apply to those Districts not having an accepted Nominee.
- After the December 15 deadline, any other nominations shall be made from the floor of the Convention in accordance with Section 9.01 of the FREA Bylaws.
- The documentation received for nominations will be reviewed by the Nominations Committee.
- All nominees will be notified of Committee action.
- Nominees selected for the slate will be contacted for reaffirmation of willingness to serve.
- The biographical sketch and photograph will be published in the Spring issue of the **FREA Bulletin** as required by the FREA Bylaws.
- Voting on the slate of nominated officers will occur during the **FREA Annual Convention.**
