## PIA SCHOLARSHIP

### Eligibility

- The Scholarships will be presented to Minnesota high school graduating seniors or full-time post-secondary students.
- Applicant must be a resident of Minnesota.
- Applicant must be the child, stepchild, grandchild, niece or nephew of an owner or employee of a PIA member agency in good standing.
- Applicant must be graduating from a Minnesota high school or a full-time post-secondary student.
- Applicant must have a 3.0 grade point average for their most recent semester.
- A certified copy of the transcript must be included with the application.
- Applicant must be accepted to or attending a post-secondary education facility (i.e. accredited college, university or technical school).
- Applicant must submit a written essay on a topic chosen by the Scholarship Selection Committee.
- All applications must be postmarked on or before April 12, 2021, in order to qualify.

### Selection

Members of the Scholarship Selection Committee will review all applications to ensure eligibility.

The recipients will be selected by blind assessment from all qualifying applications.

Scholarship recipients will be notified by May 1st, 2021.

### Distribution

The recipient must maintain a minimum 2.75 cumulative grade point average at the post-secondary education facility.

The scholarship award will be paid jointly to the educational institution and the recipient following the completion of the first semester and receipt of current transcript verifying GPA..
