ITINERARY

DAY 1: October 7, 2021 - Departure from the USA on your overnight flight to Iceland

DAY 2: October 08, 2021 – AIRPORT TRANSFER WITH REYKJAVÍK CITY SIGHTSEEING. Upon arrival, proceed through customs and collect your luggage. A Jet Vacations professional guide will personally greet you. Departure and transfer by deluxe coach to downtown capital city of Reykjavik where we will first have breakfast. After breakfast, depart on a sightseeing tour of the city's major attractions, including: the Parliament, the National Museum, Laugadalur swimming pool, the Ásmundur Sveinsson Sculpture museum, the Pearl, Höfði house (site of the 1986 summit) and the city's main landmark, Hallgrímskirkja. There's no better way to get to grips with everything Reykjavík has to offer in just a few hours. Afterwards, transfer to your hotel for check-in and rest. In the evening, you may rest or join an optional tour: NORTHERN LIGHTS BY BOAT. Hunting the northern lights from the ocean is an amazing experience; sailing away from the coastline of Reykjavík and seeing the aurora borealis out on the North-Atlantic Ocean with beautiful mountains and the city lights in the background is something you won't forget! We sail out from the Old Harbor in Reykjavík and in only 15-20 minutes we will be in a prime location away from the city lights, perfect for viewing the auroras. The guide will share with you facts on the science behind this magical phenomenon that the Northern Lights are and tell you about the stories & myths from different cultures around the world. The tour takes about 2-2,5 hours depending on how early/late the lights might appear. We recommend putting on our free overalls on-board that will keep you nice and warm out on the deck, listening to what the guide has to say about the lovely colors dancing in the sky. Throughout the tour we show our very own original Northern Lights video, full of interesting facts and folklore. So, if you are cold you can grab a drink at the bar and cozy up inside watching the video or just simply enjoy the view of the city lights in the distance with your friends/family. Back to your hot

DAY 3: October 09, 2021 SOUTH SHORE ADVENTURE

After breakfast at the hotel, embark on a journey through the stunning landscape of Iceland 's south coast. This is the land of Njál's Saga – a region of breathtaking scenery and legendary stories. During your guided tour you will encounter the wonderful variety of the southern landscape: from the wide plains formed by glacial rivers, to the sheer sea cliffs of Dyrhólaey or Reynishverfi, and to the spectacular waterfalls of Seljalandsfoss and Skógafoss. In clear weather you'll experience unforgettable views of the Hekla and Eyjafjallajökull volcanoes and, if the conditions are right, the Westman Islands. **Included: Lava Centre:** The Lava Centre is an interactive, high-tech educational exhibition depicting volcanic activity, earthquakes and the creation of Iceland. Exhibition and Cinema. Lunch is included today. Hotel and overnight. (B, L).

***Tonight we will overnight in the small town of VIK, where if the conditions are right, we will have a second opportunity to experience Northern Lights.

DAY 4: October 10, 2021 THE GOLDEN CIRCLE

Breakfast at your hotel. If you only take one guided tour while you are in Iceland, then it has to be the Golden Circle. Today we make our way back to Reykjavík via the Golden Circle. Combining natural and historical wonders, you'll experience Iceland 's landmark attractions in one incredible day: the magnificent Gullfoss waterfall, the spouting hot springs of Geysir, and Þingvellir national park, site of the Viking parliament and over 1000 years of history. Lunch today will be at the Friðheimar Greenhouse and horse farm. Overnight at your hotel (B, L)

DAY 5: October 11, 2021 OPTIONAL ENCHANTING SNÆFELLSNES PENINSULA OR FULL DAY AT LEISURE

Breakfast at your hotel. Today, spend the day at leisure exploring Reykjavik, or join the **optional tour** known as "Iceland in a Nutshell", **Snæfellsnes Peninsula's** ever-changing landscape contains examples of most land features that can be found in Iceland. Snæfellsnes was also the setting for some of Iceland's greatest Sagas. The main attraction is, with no doubt, Snæfellsjökull glacier, a beautifully-shaped strato-volcano at the very tip of the peninsula. The glacier, along with its surrounding unspoiled natural wonders, is the setting of Jules Verne's novel Journey to the Centre of the Earth. Stroll in a unique landscape with a mixture of sandy hills, black lava and yellow beaches in Búðir. Arnarstapi is perfect for a walk along the sea cliffs, where you can see spectacular columnar rock formations that are home to seabirds (puffins generally in Iceland between mid-May and early August). Then explore Djúpalónssandur's black-pebbled beach before winding around the scenic peninsula and back towards Reykjavík. Tonight, enjoy a group farewell 3 course dinner in Reykjavík. Overnight at your hotel. (B, D)

DAY 6: October 12, 2021 DEPARTURE TRANSFER VIA BLUE LAGOON

Breakfast at the hotel. On your final day your journey leads through rugged lava fields to the Blue Lagoon, a unique natural pool of mineral rich geothermal water located in the middle of a lava field in the pure, beautiful Icelandic wilderness. The Blue Lagoon is known for its special properties and its beneficial effect on the skin and attracts visitors from all over the world in search of health, relaxation and an exotic experience. You stop for a refreshing bath or swim in the pleasantly warm mineral-rich water, reputed for its healing properties. Afterwards your private driver will transfer you to Keflavik Airport for your flight. Depart for home with many incredible Icelandic memories. (B).

****For those choosing to do the optional extension, you will spend the overnight in Iceland, and continue to Finland in the early AM on October 15th.

NOTE: This tour includes moderate physical activity. The itinerary blends some longer days with shorter days and more leisure time. Walking tours, as well as walking slightly longer distances, up stairs or on uneven walking surfaces should be expected.

Day 6: October 12, 2021: Overnight Reykjavik. (B)

DAY 7: October 13, 2021 - AIRPORT TRANSFER AND FLIGHT TO Helsinki, FINLAND.

Upon morning arrival to Helsinki, set out on a full day tour of city. As a city of seasons, Helsinki thrives during the summer and, with the harbor serving as the pulse of the city, you will be quick to fall in love after disembarking your ship. Finland's largest city provides the cultural perks of a metropolitan area, while still holding on to the unique flavor that has made Helsinki stand out amongst the capitals of the Baltic. Enjoy sights such as the Helsinki Cathedral, senate square house, the Temppeliaukion Church, known as The Rock Church by travelers. It is famous by unique architecture and attracts thousands of visitors every year. Tonight, enjoy a group dinner this evening. Overnight at your hotel in Helsinki. (B.D)

DAY 8: October 14, 2021 HELSINKI - STOCKHOLM.

Breakfast at the hotel. Spend the day at leisure exploring Helsinki on your own. We suggest the Old Market Hall, Etelaranta along the South Harbor, such a beautiful place to give a try to tasty Finnish food, coffee and do local souvenir shopping. You may also join an **optional tour to Porvoo**. An hour's drive beyond Helsinki, you will travel to Porvoo, the second oldest town in Finland. Arriving in Porvoo, you'll see why it was an important trading post as far back as the 13th century. The red riverside storehouses formed a medieval harbor where salt and other products were imported. Small, low houses and picturesque yards line the narrow streets of this historical wooden town center. The prize of the city is the Grand Church, first built in the 13th century and now reflecting a profile of the 15th century. The town has become a magnet for many artists who have lived and worked in the town. Finnish national poet J.L. Runeberg, painter Albert Edelfeldt, and sculptor Ville Vallgren have all been inspired by Porvoo's charm. The town is alive with the work of current artists and writers. Lunch will be included in a nearby Villa. Then, in the late afternoon, transfer from your hotel to the Ferry for your overnight cruise to Stockholm. Buffet dinner and drinks are included on the ship (B, D)

DAY 9: October 15, 2021 STOCKHOLM.

Breakfast on the ship. Following pickup at Stockholm's cruise port, board your tour bus for a scenic ride through downtown Stockholm. Take a guided tour of the Vasa Museum, home to the world's best-preserved 17th-century warship, which sat on the floor of Stockholm Harbor for more than 300 years. Resume the scenic drive through the city, making stops at Riddarholmen Island and Fjällgatan. See the Royal Opera, the Palace, the Parliament Building, and other highlights, as well as the scenic Strandvägen and tony Östermalm. In Gamla Stan, Stockholm's Old Town, disembark for a walking tour. Wind through the medieval town's narrow alleyways to see landmarks such as Järnpojk and Storkyrka. Once your tour winds down, spend some free time window shopping or grabbing a bite to eat before checking-in into your hotel for the night. Overnight in Stockholm. (B)

DAY 10: October 16, 2021 DEPARTURE DAY.

Breakfast at the hotel. Transfer to the airport for your flight back to the U.S.A. (B)

Passenger Cancellation Policies: No charges other than the non-refundable initial service feel/deposit are levied for individual passengers canceling up to 91 days prior to the commencement of Jet Vacations LLC services. - -30 days after reservation: A service fee of \$250 becomes non-refundable.
